Income tax return for a Montana resident filing as single or married filing jointly with no dependents

Amended Return section with checkboxes and fields for names, social security numbers, and address.

Filing Status (check only one box) 1. Single 2. Married filing jointly

Exemptions section with checkboxes for 'Yourself' and 'Spouse' and a table for exemption counts.

Income section with numbered lines 4 through 11 for reporting wages, interest, and gross income.

Tax, Payments and Refund section with numbered lines 12 through 19 for reporting deductions, tax due, and payments.

Voluntary Check-off Contributions table with columns for Nongame wildlife program, Child abuse prevention, Agriculture in schools, and End-stage renal disease program.

Lines 20 through 22 for tax, penalty, and refund, including fields for RTN# and ACCT#.

For example: Taxable income \$4,500 X .03(3%) = \$135. \$135 minus \$67 = \$68 tax

Standard Deduction Worksheet for Form 2EZ

1. Enter your Montana adjusted gross income from Form 2EZ, line 11 here.....1.
2. Multiply the amount on line 1 by .20 (20%) and enter the result here2.
3. Enter the amount below that corresponds to your filing status here.....3.
 - If your filing status is single (filing status 1) enter \$3,710. This is your maximum standard deduction.
 - If you filing status is joint (filing status 2) enter \$7,420. This is your maximum standard deduction.
4. Enter the amount from line 2 or 3, whichever is smaller4.
5. Enter the amount below that corresponds to your filing status5.
 - If your filing status is single (filing status 1) enter \$1,650. This is your minimum standard deduction.
 - If your filing status is joint (filing status 2) enter \$3,300. This is your minimum standard deduction.
6. Enter here and on Form 2EZ, line 12, the amount from lines 4 or 5, whichever is larger.
This is your standard deduction.6.
