The U.S. Department of Veterans Affairs (VA) recently admitted that sensitive personal information for up to 26.5 million veterans, spouses, active duty, National Guard, and Reserve members was compromised by the negligent actions of a VA employee. Ignoring VA rules, this employee brought home a government computer containing a data file with the names and Social Security numbers of these veterans, and the computer was subsequently stolen during a burglary.

This episode represents one of the largest compromises of personal information in American history, and a clear collapse of VA protocols for protecting personal data. With another person's Social Security number and other information, an imposter can open credit accounts, make fraudulent charges, or withdraw money. Upon learning of this incident, I called immediately for an investigation into why VA's internal safeguards failed, and what needs to be done to prevent future loss of veterans' personal data. I also sent letters and e-mails to leaders of veterans organizations throughout Central New Jersey to alert them of the theft and provide information on how their members can protect themselves.

Our veterans deserve the full facts concerning this incident and the assurance that any violations of federal law will be vigorously prosecuted. They also deserve protections. That is why I have cosponsored the *Veterans Identity Protection Act*, which would grant free credit monitoring and immediate notification to all those who had personal information compromised by this incident. ▶

Protect Yourself From Identity Theft

If you have not already, you should call the VA at 1-800-FED-INFO (333-4636). Additionally, if you find suspicious activities on your credit report:

- Contact the credit bureau to have the information corrected and fraudulent account closed;
- If a credit card was used, alert the issuer to the fraud/mistaken charge and consider closing the account;
- Report the theft to the Federal Trade Commission at www.ftc.gov/idtheft or by phone: 1-877-ID-THEFT (438-4338).

Affordable Health Care

In President Bush's 2007 budget plan, he proposed to raise TRICARE enrollment fees, deductibles, and pharmacy co-payments for retired service members. I strongly oppose this plan. These hikes are unfair and unnecessary.

I was pleased that the 2007 defense authorization bill, approved by the House on May 11, blocked these cost increases through the end of next year. Retired members of the Armed Forces and their dependents deserve to know that the federal government will honor their service by keeping health care affordable and accessible. ▶

The New GI Bill of Rights

Last month saw the death of Sonny Montgomery, a former Congressman from Mississippi who left a legacy of advocating for active duty and retired Armed Forces personnel. The Montgomery G.I. Bill expanded the educational assistance programs available for veterans who are making the transition to civilian life. Rep. Montgomery's work helped the recruitment and retention of qualified Armed Forces personnel, and boosted our economic growth by investing in our talented workforce. Sixty years after the first assistance was offered to those returning from combat in World War II,

I am working to pass *The New G.I. Bill of Rights for the 21st Century*. This legislation would improve benefits for the men and women currently serving our country – including National Guard and Reserve forces – and provide overdue assistance that military retirees deserve. For example, it would fully repeal the Disabled Veterans Tax (which prohibits veterans from receiving concurrently disability benefits and their military pension) and the Military Families Tax (which penalizes survivors of those killed in combat). ▀
