

The Federal Trade Commission at 100: Brussels Public Consultation

Tuesday, October 21, 2008



Antonio BAVASSO is a partner at Allen & Overy. His expertise covers all areas of antitrust law, State aid and EU internal market. He has been involved in a number leading merger and behavioural investigations and has a specific expertise in communications, broadcasting, media and technology. Previously, he was the European General Counsel of one of GE's business divisions, GE Industrial Systems. Prior to joining GE, Hendrik was a member of the Brussels and New York Bars, and an attorney with Jones Day, based in Washington DC and Brussels, where he practiced mainly US antitrust, and respectively European competition law. He has an LL.M degree from Harvard Law School and obtained his law degree at the Rijksuniversiteit Gent, Belgium. He is a frequent speaker and writer on competition law issues.

Rachel BRANDENBURGER is a partner in Freshfields Bruckhaus Deringer's antitrust, competition and trade group. She works in the firm's Brussels and London offices. She has led many cases in front of both the European Commission and UK regulators. Her major cases include EC Merger Regulation (first and second stage) inquiries; inquiries under Articles 81 and 82 of the EC Treaty into anti-competitive practices, dominant positions and cartels; and proceedings before the European Court of Justice. In the UK, her cases involve inquiries by the Office of Fair Trading and the Competition Commission, as well as the industry-specific regulators (eg the Office of Communications, the Office of Gas and Electricity Markets and the Office of Water Services). She has also advised on UK High Court judicial review proceedings against some of the UK regulators.

Götz DRAUZ joined Howrey's Brussels office as a Partner in 2006. Prior to joining Howrey, Mr. Drauz served for 25 years at the European Commission, most recently, as the Deputy Director-General in DG Competition with particular responsibility for mergers. In that role, Mr. Drauz managed and coordinated the merger control activity

within DG Competition. His more recent achievements include launching a Commission inquiry into the functioning of competition in the electricity and gas sectors in 2001, and managing the settlement of a long-standing Article 82 inquiry into Coca-Cola's European sales practices in 2004. In addition to his most recent role as Deputy Director-General, Mr. Drauz has served in various other roles at the European Commission, including Director of the Merger Task Force in DG Competition, Assistant to the Director General of DG Competition and Coordinator for distribution and franchising cases in Directorate for Competition Policy and Coordination.

Luc GYSELEN is a partner at Arnold & Porter, Brussels, where he is responsible for advice and representation before EU and national agencies on merger control, abusive conduct, cartels, other restrictive practices, and state aids. Mr. Gyselen joined the firm in 2004 after 20 years of public service at various EU institutions. He spent most of his time at the European Commission (EC), where he was a member of the Legal Service in the early years of his career and later held several senior positions in the Directorate-General for Competition (DG COMP). During his four years as special assistant to the Director-General in DG COMP (1990-1994), he oversaw the entire range of EU competition policy activities, including the introduction of EC merger control, and acted as liaison officer between DG COMP and the Commissioner in charge of competition policy and his personal staff. Between 1994 and 2004, he played a key role in many leading antitrust cases. In the area of abusive conduct, these included *Coca Cola* (rebates, exclusive dealing, category management)—a case which led him to write an comprehensive article on rebates that received high visibility in the business community.

Jonas KOPONEN is a partner at Linklaters, Brussels, where he has considerable experience of commercial and contentious matters involving EC law, antitrust and merger control law, and the application thereof before EC institutions as well as national authorities and courts.
