1. NEW VALUES FOR DEPENDENT-PATERNITY-STATUS FIELD (OCSE REF #202)

The Child Support Enforcement Network (CSENet) application is being modified to add new values for the Dependent-Paternity-Status field in the Order data block.

1.1 Summary of Changes

The valid values for the Dependent-Paternity-Status field are being expanded to identify the method by which paternity was established. This change will support the Uniform Interstate Family Support Act (UIFSA) standard forms.

1.2 Background

The Continuous Service Improvement (CSI) team identified gaps and proposed changes that were shared with State representatives during Interstate Communications Teleconferences on January 19, 2007 and March 15, 2007. Feedback was obtained, suggestions considered and proposed changes developed.

During the April 5, 2007 conference call with State representatives, a long list of CSENet enhancements compiled over several years was discussed, along with a shorter list of items identified by States as a priority. States were asked about their willingness and ability to make the changes. Some States expressed concern about limited programming resources and other priorities. Therefore, the group recommended reducing the number of changes to minimize State impact. As a result, several enhancements including new transactions and values were presented to State representatives on May 3, 2007. Four of these were subsequently approved by OCSE as high-priority items for inclusion in Release 08-02, based on several factors: requests by States, changes in requirements in the Code of Federal Regulations, enhancement of electronic communications, and electronic support of paper-based UIFSA forms.

1.3 Description of Changes

The valid values for the Dependent-Paternity-Status field are being expanded to identify whether paternity has been established and specifically the method by which paternity was established. The modification will allow for additional values other than the current value of Y indicating "Paternity status determined".

- Existing Values:
 - N (or blank) Paternity status not determined
 - Y Paternity status determined

- New Values:
 - 1. Born in Wedlock
 - 2. Paternity established through genetic testing
 - 3. Paternity not an issue (adoption)
 - 4. Paternity established judicially (order)
 - 5. Paternity established through acknowledgement
 - 6. Other

The following current error code remains in effect:

• E567, "Invalid Dependent Paternity Status".

All current requirements for the Dependent-Paternity-Status field remain in effect.

Although the Information data block is not required, it is recommended that the Information data block be included in the transaction when the value '6' is chosen for the Dependent-Paternity-Status field, to provide information about how paternity was established.

1.4 Impact on States

If States make all the changes necessary to comply with the expanded valid values for the Dependent-Paternity-Status field, there should be no impact. However, States that do not program the new valid paternity values may experience an impact with incoming new values and how they are processed. States that do not program for the new values may have existing edits that reject the values. If this is the case, the data may not be received and stored.

The software is being implemented on October 3, 2008 in time for the afternoon cycle.

1.5 Pilot Testing

States may elect to participate in pilot testing from September 15 to September 26, 2008 to verify system programming. Pilot testing provides States an opportunity to exchange transactions via test data sets with:

- the CSENet Application using FIPS code 9100000,
- other States participating in pilot testing, or
- their own system through "loopback" testing.

States may also elect to test receiving transactions from the CSENet Testdeck application.

2. CREATE NEW TRANSACTION TO SUPPORT FEDERAL TAX OFFSET TRANSMISSION NOTIFICATION (OCSE REF #296)

The Child Support Enforcement Network (CSENet) application is being modified to support a new response/provision of information (P) transaction in the Collection (COL) Function code. This will notify another State that an interstate case has been submitted for Federal tax offset.

2.1 Summary of Changes

The COL P CISUB is being added to the CSENet application to provide States the ability to send and receive a notification that an interstate case has been submitted for Federal tax offset. This activity is not currently supported in CSENet with a unique transaction, and it corresponds directly to the requirements in Code of Federal Regulations 45CFR 303.72(d) (1).

This new transaction facilitates the ability to electronically generate a required notification.

2.2 Background

Identified gaps and proposed changes were shared and discussed with State representatives during Interstate Communications Teleconferences on January 19, 2007 and March 15, 2007. Feedback was obtained, suggestions considered, and proposed changes developed.

During the April 5, 2007 conference call with State representatives, a long list of CSENet enhancements compiled over several years was discussed, along with a shorter list of items identified by States as a priority. States were asked about their willingness and ability to make the changes. Some States expressed concern about limited programming resources and other priorities. Therefore, the group recommended reducing the number of changes to minimize State impact. As a result, several enhancements including new transactions and new values were presented to State representatives on May 3, 2007. Four of these were subsequently approved by OCSE as high-priority items for inclusion in Release 08-02, based on several factors: requests by States, changes in requirements in the CFR, enhancement of electronic communications, and electronic support of paper-based UIFSA forms.

2.3 Description of Changes

This enhancement adds a new transaction, COL P CISUB, to support the Code of Federal Regulations (CFR) 45CFR 303.72(d)(1):

"Notification of changes in case status. (1) The State referring past-due support for offset must, in interstate situations, notify any other State involved in enforcing the support order when it submits an interstate case for offset."

This new COL P transaction requires Header, Case, and NCP_ID data blocks. Because of the nature of this transaction, the Collection data block is not required. The transaction has the following requirements:

 The Header data block should be formatted according to current requirements and must contain CISUB in the Action-Reason field.

All current requirements remain in effect for all data blocks included in this transaction, with the addition of the new requirement.

2.4 Impact on States

To send this new transaction, States need to add CISUB as a Reason code for the COL P to their CSE systems. States should also be prepared to receive transactions with this code. To exchange this transaction, States must have open exchange agreements for the COL Function code with their partners. To enable or expand exchange agreements, State representatives should contact their CSENet 2000 technical representative or the CSENet Service Desk.

States using the COL P CISUB transaction will be in compliance with AT-04-08 (November 5, 2004) from OCSE requiring that the State referring past-due support for offset must, in interstate situations, notify any other State involved in enforcing the support order when it submits an interstate case for offset.

The software is being implemented on October 3, 2008, in time for the afternoon cycle.

2.5 Pilot Testing

States may elect to participate in pilot testing from September 15 to September 26, 2008 to verify system programming. Pilot testing provides States an opportunity to exchange transactions via test data sets with:

- the CSENet application using FIPS code 9100000,
- other States participating in pilot testing, or
- their own system through "loopback" testing.

States may also elect to test receiving transactions from the CSENet Testdeck application.

CSENet technical representatives will be available to provide analysis and feedback concerning test transactions during the September 15 to September 26, 2008 timeframe. 3. CREATE NEW TRANSACTION TO SUPPORT CHANGE OF PAYEE (OCSE REF #298)

The Child Support Enforcement Network (CSENet) 2000 application is being modified to support a new request (R) transaction for the Managing State Cases (MSC) Function code for a change of payee.

3.1 Summary of Changes

The MSC R GRPAY transaction is being added to the CSENet Application to provide States the ability to send and receive a request for a change of payee. This activity, which is not currently supported in CSENet with a unique request transaction, corresponds directly to an action found in Transmittal #1 – Initial Request and Transmittal #2 – Subsequent Actions of the Intergovernmental (UIFSA) forms.

This new transaction promotes electronic, standardized interstate communications.

3.2 Background

Identified gaps and proposed changes were shared and discussed with State representatives during Interstate Communications Teleconferences on January 19, 2007 and March 15, 2007. Feedback was obtained, suggestions considered, and proposed changes developed.

During the April 5, 2007, conference call with State representatives, a long list of CSENet enhancements compiled over several years was discussed along with a shorter list of items identified by States as a priority. States were asked about their willingness and ability to make the changes. Some States expressed concern about limited programming resources and other priorities. Therefore the group recommended reducing the number of changes to minimize State impact. As a result, several enhancements including new transactions and values were presented to State representatives on May 3, 2007. Four of these were subsequently approved by OCSE as high-priority items for inclusion in Release 08-02, based on several factors: requests by States, changes in requirements in the CFR, enhancement of electronic communications, and electronic support of paper-based UIFSA forms.

3.3 Description of Changes

This enhancement adds a new transaction, MSC R GRPAY, to support the electronic communication of the current interstate business conveyed by the UIFSA forms.

This new MSC R transaction requires Header, Case, NCP_ID, and at least two Participant data blocks, with the following requirements:

• The Header data block should be formatted according to current requirements and must contain GRPAY in the Action-Reason field.

- The Case data block requires the Payment-Mail-Address-Line-1 field to be filled.
- One Participant data block requires a 'C' indicating custodial party in the Relationship field.
- The second Participant data block requires a 'D' indicating dependent in the Relationship field.

All current requirements remain in effect for all data blocks included in this transaction, in addition to the new requirements.

No new error codes and messages will be generated as a result of using this new transaction.

3.4 Impact on States

To send this new transaction, States need to add GRPAY as a Reason code for the MSC R to their CSE systems. States should also be prepared to receive transactions with this code. To exchange this transaction, States must have open exchange agreements for the MSC Function code with their partners. To enable or expand exchange agreements, State representatives should contact their CSENet 2000 technical representative or the CSENet Service Desk.

Using the MSC R GRPAY transaction supports the electronic communication of the current interstate business conveyed by the UIFSA forms.

The software is being implemented on October 3, 2008 in time for the afternoon cycle.

3.5 Pilot Testing

States may elect to participate in pilot testing from September 15 to September 26, 2008, to verify system programming. Pilot testing provides States an opportunity to exchange transactions via test data sets with:

- the CSENet Application using FIPS code 9100000,
- other States participating in pilot testing, or
- their own system through "loopback" testing.

States may also elect to test receiving transactions from the CSENet Testdeck application.

CSENet technical representatives will be available to provide analysis and feedback concerning test transactions during the September 15 to September 26, 2008 timeframe. State representatives should contact their CSENet technical representative or the CSENet Service Desk at 800.258.2736 or CSENet.2000@lmco.com to participate.

4. CREATE NEW TRANSACTION TO SUPPORT REQUEST PATERNITY AND ESTABLISHMENT (OCSE REF #300)

The Child Support Enforcement Network (CSENet) 2000 application is being modified to support a new request (R) transaction for the Establishment (EST) Function code to request both paternity establishment and order establishment simultaneously.

4.1 Summary of Changes

The EST R SRPAT is being added to the CSENet application to provide States the ability to send and receive a single transaction to request the establishment of both paternity and support. This is the most frequently requested combination of multiple actions. Currently CSENet supports two separate transactions, one to request the establishment of paternity and the other to request the establishment of a support order.

This new transaction better meets the interstate business needs and promotes electronic, standardized interstate communications.

4.2 Background

Identified gaps and proposed changes were shared and discussed with State representatives during Interstate Communications Teleconferences on January 19, 2007 and March 15, 2007. Feedback was obtained, suggestions considered, and proposed changes developed.

During the April 5, 2007 conference call with State representatives, a long list of CSENet enhancements compiled over several years was discussed, along with a shorter list of items identified by States as a priority. States were asked about their willingness and ability to make the changes. Some States expressed concern about limited programming resources and other priorities. Therefore the group recommended reducing the number of changes to minimize State impact. As a result, several enhancements including new transactions and values were presented to State representatives on May 3, 2007. Four of these were subsequently approved by OCSE as high-priority items for inclusion in Release 08-02, based on several factors: requests by States, changes in requirements in the CFR, enhancement of electronic communications, and electronic support of paper-based UIFSA forms.

4.3 Description of Changes

This enhancement adds a new transaction, EST R SRPAT, to provide States the ability to send and receive a single request transaction requesting the establishment of both paternity and support.

This new EST R transaction requires Header, Case, NCP-ID, NCP-Locate, and at least two Participant data blocks, with the following requirements:

- The Header data block should be formatted according to current requirements and must contain SRPAT in the Action-Reason field.
- One Participant data block requires a 'C' indicating custodial party in the Relationship field.
- The second Participant data block requires a 'D' indicating dependent in the Relationship field.

All current requirements remain in effect for all data blocks included in this transaction, in addition to the new requirements.

No new error codes and messages will be generated as a result of using this new transaction.

4.4 Impact on States

To send this new transaction, States need to add SRPAT as a Reason code for the EST R to their CSE systems. States should also be prepared to receive transactions with this code. To exchange this transaction, States must have open exchange agreements for the EST Function code with their partners. To enable or expand exchange agreements, State representatives should contact their CSENet 2000 technical representative or the CSENet Service Desk.

Using the EST R SRPAT transaction supports the electronic communication of the current interstate business conveyed by the UIFSA forms.

The software is being implemented on October 3, 2008 in time for the afternoon cycle.

States may elect to participate in pilot testing from September 15 to September 26, 2008, to verify system programming. Pilot testing provides States an opportunity to exchange transactions via test data sets with:

- the CSENet Application using FIPS code 9100000,

States may also elect to test receiving transactions from the CSENet Testdeck Application.

CSENet technical representatives will be available to provide analysis and feedback concerning test transactions during the September 15 to September 26, 2008 timeframe. 5. STATES CONVERSION TO CONNECT: Direct AT THE NCC (OCSE REF #308)

The Child Support Enforcement (CSENet 2000) application is now being hosted at the Social Security Administration's National Computing Center (NCC) in Woodlawn, MD, along with most of the other federal applications, such as the Federal Case Registry (FCR) and the National Directory of New Hires (NDNH). OCSE is now prepared to have States begin exchanging CSENet files directly with the NCC using CONNECT:Direct with Secure+ (C:D). This project supports States' conversion from CSENet file transfers across the OCSE Network to C:D with the NCC.

5.1 Summary of Changes

The transmission method of transferring CSENet transaction data to and from the States will be changed. The current method of transmission is across the OCSE Network. The new method of transmission will be by C:D directly with the NCC.

5.2 Background

Since 1999, State Child Support Enforcement agencies (CSE) have been using the CSENet application to exchange interstate case data and the OCSE Network to exchange those data files.

As part of OCSE's on-going effort to improve its child support services and infrastructure, a decision was made to consolidate Federal applications and supporting communication methods to the NCC. As of January 2008 the CSENet application is hosted at the NCC and was moved into production in March 2008. The application now processes all CSENet files from the NCC.

OCSE is beginning the conversion process wherein States will send CSENet files across C:D to the NCC and cease using the OCSE Network. All States will be migrated to C:D within the next two years.

5.3 Description of Changes

Currently States transmit CSENet transactions across the private OCSE Network.

Each State will be required to change its transmission procedures for CSENet transactions to mirror the processing executed for FCR data transfers directly with the NCC.

Each State currently has a direct connection with the NCC where FCR and NDNH transmissions are executed utilizing C:D.

CSENet data files, picked up from the States, will be stored in EBCDIC format at the NCC regardless of the source format at the State. States will submit a C:D request process for C:D

to pick up CSENet transaction data files. To be picked up, the CSENet transaction data files will continue to be in their current format (both layout and structure). Unique C:D processes will be created for each State for each file type the State sends.

CSENet data files, sent from the NCC to the States, will be sent in the format required for storage at the State (EBCDIC or ASCII as requested by the State). CSENet data files will be sent to the State upon completion of processing at the NCC and not necessarily specifically at the 4:00 AM and 4:00 PM timeframe as is current. State's current participation in AM and PM groupings will be maintained and efforts will be made to deliver files by the 4:00 AM and 4:00 PM timeframe. However, if data files are ready earlier, they will be delivered at that time. CSENet data files, sent from the NCC to the States, will be formatted with their current logical record length (LRECL) file type.

5.4 Impact on States

The State will be responsible for any procedural changes necessary to move the CSENet transmission files from their current location to the location where the C:D connection with the NCC resides.

The State will be responsible for the development of the C:D processes necessary to request pick-up and to receive the CSENet data files at their location.

There are no changes to the content or format of the CSENet transmission files, only the method and location of their transfer. There are no changes to the functionality of the CSENet application necessary to support this communication conversion.

5.5 Migration and Deployment Process

Each State must develop and test a new process, or modify an existing process, to move the CSENet transaction files to and from the existing C:D communication point with the NCC.

The content of the CSENet transaction files is not changing; only the file transmission method is changing. Therefore, the same number of files will be exchanged as with the current method. The only difference in the number of files exchanged is that States that do not currently participate in State-to-State testing are encouraged to code for the handling of this function. The content and format of data files will not change. Instructions for interaction with the C:D team at the NCC are included in Appendix A.

During the migration process, States are expected to:

- 1. Identify key staff to coordinate this process and resources within the State to accomplish the conversion;
- 2. Set up a process to move files from the current CSENet location to the C:D transmission site;
- 3. Create automated, repeatable and scheduled file pick-up request and retrieval processes similar to what is used for FCR file transmissions;

- 4. Work with the NCC C:D team to test the transmission process with the NCC for connectivity and C:D configuration;
- 5. Coordinate efforts with the OCSE/FPLS team to test the transmission process through the CSENet application for compatibility; and
- 6. Perform the final cutover to C:D.

Initially five States began the conversion of CSENet files to the C:D transmission method in March 2008. This pilot effort is targeted for completion by June 2008. A schedule is being developed for the conversion of all States and will be available by mid-Summer 2008.

A. CSENET DATA BLOCK RECORD LAYOUT - EXCERPT

This appendix provides data layouts, field definitions and requirements necessary for the establishment of CSENet 2000 functionality on State CSE systems.

Each layout contains the following information:

Rules Denotes the rules that govern the editing of each field

Field Name Identifies the name of the data element

Location Identifies the position within the data block that the element is

located

Length Identifies, in bytes, the size of the element

A/N Designates the type of format that applies to the element

Comments Provides a description of the data element, requirements associated

with the element as well as the values that are relevant to the field

The material that is highlighted in turquoise indicates a change to existing information.

For further assistance during the programming of CSENet 2000 on the State CSE system, refer to the *CSENet IGD*, Appendix A, "Data Dictionary", and Appendix B, "Valid Transactions Table".

For additional information regarding the structure of CSENet transactions, refer to the *CSENet IGD*, Part 5, "CSENet Transaction Structure".

A.1 Transaction Structure

Every transaction is a single string of data terminated with a new line character. When a transaction is sent, the actual location (position) of each data field after the transaction header differs depending on the number of data blocks transmitted.

When transmitting CSENet 2000 transactions, the first data block must contain the Transaction Header. The header provides information about the source and destination of the transaction, the case IDs to which the transaction refers and indicators showing the number of data blocks. Data blocks containing case data transmitted from one State to another may follow the header. Although not every data block will appear in every transaction, the data blocks must appear in the order depicted in to the *CSENet IGD*, Chart C-1.

The minimum number of data blocks that must be transmitted depends on the type of transaction being sent to the *CSENet IGD*. Chart C-2 identifies the required data blocks for each CSENet 2000 transaction. The combination of Functional Type and Action codes determines the data blocks that are required for a CSENet 2000 transaction to the *CSENet IGD*. A.2 CSENet 2000 Required Data Blocks and Data Elements

The Header data block is always required and must be the first data block in each transaction. Additional data block requirements are determined by the combination of Functional Type, Action, and Action-Reason codes (located in the Header).

The Comments section of the data block layout indicates whether an element is required or conditionally required for a particular data block. Where the information is required or conditionally required, the State Child Support Enforcement (CSE) system must provide the appropriate information. If the field is not identified as required in the Comments section of the data block layout, the particular element is optional. If the optional information is provided by the CSE system, then the appropriate edits and rules for that field type will be enforced by the CSENet 2000 application. Also provided in the Comments section are the valid values (if any) for each data element, an explanation of the field and its relationship to other fields within the data block or record.

The *CSENet IGD*, Chart C-2 illustrates the data block requirements for CSENet 2000 transactions with Action codes of 'R', 'U' and 'P'.

Note: Transactions with Action codes of 'A', 'C' or 'M' require only the Header data block unless any of the data block indicators are set to one or greater, or if the Attachments Indicator is 'Y'. For definitions of Action codes, refer to the *CSENet IGD*, Appendix B, "Valid Transactions Table".

A.3 Rules Governing the Editing of CSENet Transactions

The rules listed below are applicable to all CSENet 2000 transactions. The rules are located in the first column of each data block layout.

Data transmitted to the CSENet 2000 application must comply with the following requirements:

- 1. All data must be in ASCII format.
- 2. All alphanumeric data must be in upper case.
- 3. All alphanumeric data must be left justified.
- 4. All unused fields must be left blank (blank-filled).
- 5. For numeric data:
 - All dates must be in the Year 2000-compliant format of CCYYMMDD. Acceptable date ranges are 1900-2099.
 - Dollar amounts are in the format +99999999.99. If used, the amount must be right justified and zero filled to the left. If unused, the field must be blank-filled. If negative, the minus (-) character must appear in the first position of the field. If positive, the plus (+) character (or blank fill) must be in the first position of the field. Zero may be an acceptable amount (where noted in the comments section of the record layout).

B. CONNECT: DIRECT PROCEDURES - EXCERPT

States currently exchange CSENet transactions through the OCSE Network. CSENet exchanges are being converted from the OCSE Network to the existing C:D connection with OCSE/SSA at the National Computing Center (NCC) that Federal Case Registry (FCR) uses.

The following steps should be performed by the State to accomplish this conversion:

- 1. Identify the State C:D location where data file transfers currently occur for the Federal Case Registry (FCR).
- 2. Identify the State technical contact(s) responsible for the above.
- 3. Identify the location of the current State CSENet network connection in relationship to the State's C:D location identified in Step 1.
 - If current CSENet data file transfers occur at the same location (co-located) as the C:D location, then go to Step 4.
 - If current CSENet data file transfers occur at a different location (not co-located) than the C:D location follow the steps below.
 - Develop and implement procedures to transfer CSENet data files from/to the C:D location. Use the procedures for transferring FCR files as a guide.
 - When CSENet data files can be transferred successfully from/to the C:D location, go to Step 4.
- 4. Provide the NCC C:D team the State data file names for the two files which may be picked-up from the State. These have been identified/described as:
 - CSENet Transactions for Production; and
 - CSENet Transactions for State-to-State testing.

Note: States who do not currently participate in State-to-State testing are encouraged to code for the handling of this function.

- 5. Provide the State data file names for the potentially seven files the States may receive from the NCC to the NCC C:D team:
 - The first four files are identified/described as production files with types:
 - Valid CSENet Transactions:
 - Transaction Error File;
 - Transaction Validation Report; and
 - IRG Refresh File
 - The second three files are identified/described as State-to-State testing files with types:
 - Valid CSENet Transactions;
 - Transaction Error File; and
 - Transaction Validation Report

Note: Not all States currently process all nine file types.

- 6. Because these transmissions are daily, the State file naming convention must include a method for uniqueness such as date and time stamp, GDG processing or file append processes. OCSE recommends the following data file name convention:
 - CSENet transactions picked up by C:D: ##IP.Thhmmss.Ryymmdd
 - CSENet State-to-State testing transactions picked up by C:D: ##IT. Thhmmss.Ryymmdd

- CSENet transactions returned to the State: ##OP. Thhmmss.Ryymmdd
- CSENet State-to-State testing transactions returned to the State: ##OT. Thhmmss.Ryymmdd
- CSENet Error report returned to the State: ##EP. Thhmmss.Ryymmdd
- CSENet State-to-State testing Error report returned to the State: ##ET. Thhmmss.Ryymmdd
- CSENet Validation report returned to the State: ##VP. Thhmmss.Ryymmdd
- CSENet State-to-State testing Validation report returned to the State: ##VT. Thhmmss.Ryymmdd
- CSENet IRG file returned to the State: IRGP. Thhmmss.Ryymmdd Where:

= State FIPS Code

hhmmss = Hours, Minutes, Seconds

yymmdd = Year, Month, Day

Note: States that choose a method of file management other than file appends and emptying are responsible for ensuring files are not duplicated, processed more than once or overlaid.

- 7. The State security staff will coordinate with the NCC C:D team to define security for the possibly nine data files to be transferred by C:D for the CSENet application. The security userid to be used will likely be the same one used for the current C:D data transfers for FCR.
- 8. Coordinate with the NCC C:D team to create the C:D procedures to transfer CSENet data files. These may be copied from the current State procedures used to exchange FCR files with the NCC. Procedures need to include transferring:
 - Two CSENet data files to the NCC
 - Seven CSENet data files from the NCC
