I never tire of stating that one of the greatest privileges I have as a Congressman is nominating young men and women to the United States Service Academies. Every fall so many rising seniors in the Seventh Congressional District apply for a Congressional Nomination, with the goal of obtaining one of the greatest educations in the nation. It is an important decision to attend one of the academies that prepare America's young men and women to become professional officers. There will be much hard work, and they will be held to the highest ideals of duty, honor, and loyalty.

21ST CENTURY WATER COMMISSION UPDATE

The U.S. population has recently exceeded over 305 million people, and I am sure that you will agree with me that we must act now to develop a comprehensive water policy to ensure that as the population grows, all Americans will continue to have sufficient access to a fresh supply of water. It is with this in mind that I reintroduced H. R. 135 on January 6, 2009. It is my belief that H.R. 135 will help accomplish the goal of continued fresh water protection for future generation.

With the support and enthusiasm for the creation of a 21st Century Water Commission, H.R. 135 was reported out of the House Committees on Natural Resources and Transportation and Infrastructure in 2008, but unfortunately Congress adjourned before being able to consider the legislation on the House floor. I am also pleased to report that with the help of my colleague, Senator Johnny Isakson (R-GA), H.R. 135 was favorably reported out of the Senate Environment and Public Works Committee last year for the first time. We are getting closer and closer to making this a reality, but we must continue our efforts in the 111th Congress.

INTERNSHIP OPPORTUNITIES

As we all know, educating the youth of our nation about the government is a critical component in continuing to build a strong nation. As your representative, I feel it imperative to afford our youth opportunities to obtain a true appreciation and working knowledge of our government. There are some opportunities available through my Seventh District Internship Program. Participation in my Internship Program is open to any college or university student and internships are available in both my Washington, D.C., Office and my Georgia District Office.
