## Major Developments

# Update: Over 975,000 Customers Remain Without Power across U.S. Midwest Due to Ice Storms

Snow and ice storms across the U.S. Midwest knocked out power to approximately 1,615,778 customers in states from Oklahoma to Pennsylvania. Heaviest hit states include Arkansas, Kentucky, and Ohio. As of most recent reports, utilities report 978,662 customers remain without power. The following table lists peak and latest reported outage figured, based on multiple sources.

#### Update: Refineries Nationwide Could be Affected by Possible Labor Strike Starting over Weekend

About 24,000 refinery and pipeline workers across the United States are prepared to go on strike at midnight Saturday if negotiations with major oil companies don't result in a new contract. The current contract expires at 12:01 AM Sunday. The strike would affect more than half of the nation's refining capacity. Shell's Deer Park, Texas refinery, BP's Texas City, Texas refinery, Lyondell's Houston, Texas refinery, and Pasadena's Pasadena, Texas refinery are among the refineries that can be affected. Valero indicated it may idle its Memphis, Delaware refinery but continue operations at its Port Arthur, Texas refinery with replacement workers if the strike goes into affect. BP has told union leaders it would not train replacement workers to operate refineries, and will idle some refineries. Lyondell has trained management personnel to operate its Houston, Texas refinery. Shell and ExxonMobil place on using replacement workers to keep their refineries operating. Marathon's Texas City, Texas refinery and ExxonMobil's Baytown, Texas refineries are included in the bargaining, but their contracts don't expire until later.
