Annual Fireline Safety Refresher Training

Why Refresher Training?

The purpose of wildland fire suppression is to minimize damage to resources, property and the environment. This should be accomplished in the most operationally effective and fiscally responsible manner. But above all, we need to remember that no resource or property values are worth endangering life. Providing for the safety of firefighters is the number one priority and responsibility of every individual.

The objective of this presentation is to review the 10 Standard Fire Orders, 18 Watchout Situations, LCES, Downhill Line Construction, and Urban Interface.

This refresher video course is intended as an alternative to annual safety refresher training, which is required for all personnel participating in fire suppression or prescribed fire duties, specifically for fire personnel with fireline/operation qualifications, and non-fire personnel who have reason to be on the fireline unescorted.

NOTES TO FACILITATOR

The success of this presentation is dependent on your ability to stimulate meaningful discussion during the break out exercises, field discussion and think points. Key talking points are listed below under the Presentation Time Frames. This is not a plug-and-play presentation! When used as a video course, review the tape prior to the class. The facilitator of this course should have a wide range of wildland and firefighting experience and techniques.

Introductory Topics for Group Discussion

Wildland firefighting is an arduous and high-risk job. Mitigating and reducing risks and improving fire safety is everyone's responsibility.

Prior to the program, discuss with students what safety means to them (5 -10 min.)

Points for discussion:

-personal safety

- -crew safety
- -public safety

-other potential safety factors such as vehicles, snags, rocks ...

Urban Interface Potential Topics for Group Discussion

Urban Interface concerns differ by region. Use these topics to open a discussion during the urban interface module.

- Personal experience/war stories
- Unique issues in your area: power lines livestock/farms/ranches communications hazmat defensible space water supply terrain evacuations bridges street access/egress

cooperative agreement crew safety/public safety pre-suppression plans

Record key points on a flip chart.
