SUBJECT: Distribution of the Hatch Act Funds for Fiscal Year (FY) 2006

Included in this email transmission is a copy of CSREES-OD-1088-D, Distribution of Hatch Act Funds, for FY 2006. The distribution identifies funds for the Small Business Innovation Research Program, reflecting the requirement that not less than 2.50 percent of the funds be set aside for that purpose in FY 2006. The distribution also identifies a set aside for biotechnology risk assessment.

Section 203 of the Agricultural Research, Extension, and Education Reform Act of 1998 requires that all funds authorized under the Hatch Act, including Hatch Multistate Research Funds, be fully matched out of non-Federal funds. In addition, the matching requirement for 1862 Land-Grant Institutions in the U.S. Territories is 50 percent of the Federal formula funds per section 7213 of the Farm Security and Rural Investment Act of 2002 (FSRIA) (Pub. L. No. 107-171).

A Planning and Reporting page has been established on our website to assist you in locating the requirements, due dates, and submission information for the Hatch Regular and Hatch Multistate Research formula funds and all other formula funds. The research and extension formulas are organized in groups for the three land-grant types: 1862 Land-Grant Institutions, 1862 Land-Grant Institutions in the U.S. Territories, and 1890 Land-Grant Institutions. Since funding continues to be contingent upon planning and reporting requirements, you may want to have your administrative staff bookmark the following web link for easy access to fillable forms and due dates for all formula funds:
