The Department of Forestry, in an effort to aid landowners to "develop the forest resources of the state," enters into an agreement with the landowner(s) as follows:

## IT IS MUTUALLY AGREED

service of the Department of Forestry to carry out a prescribed burning project for forestry purposes, on approximately

A. THE LANDOWNER WILL:

- 1. Accept full responsibility for damage to landowner's own property and for injuries to landowner's person. Accept full responsibility for and hold the Department harmless from and against payment of all civil damage claims arising out of the performance of this agreement including, without limitation, claims for injury to persons (including death) or damage to property made by third parties and by agents or employees of the landowner. The landowner will reimburse the state and county for costs of suppressing the fire should the fire escape beyond prepared control lines. (It is suggested that the landowner contact their insurance agent to arrange for liability coverage and to be sure that adequate casualty insurance is in effect to protect landowner's own property).
- 2. Set the initial fire on the area to be burned and continue firing for the distance of at least 300 feet along established control lines. The landowner will provide necessary personnel to patrol and safeguard the burned area until the fire is dead-out.
- 3. Pay to the State Forester, within thirty (30) days of receipt of an itemized statement, the total amount due for all services, supplies, and equipment costs. Charges will be made on the basis of current rates established by the State Forester.
- 4. Observe the forest fire laws and air pollution regulations of Virginia pertaining to this prescribed burning operation.

## B. THE DEPARTMENT OF FORESTRY WILL:

- 1. Prepare a smoke management plan utilizing current and expected weather forecasts.
- 2. Prepare or supervise the preparation of interior and/or exterior fire lines.
- 3. Provide a supervisory Department employee(s), necessary hand tools, equipment, and a tractor fire plow unit and operator during the prescribed burning operation. The Department of Forestry will exercise necessary skills and responsible care in prescribed burning, but gives no warranty, expressed or implied, as to the effectiveness or control of the prescribed burning operation.
