Peer Review Comments and Authors' Responses

Twenty-four peer reviewers submitted comments by the closing date of the review. Peer reviewers were asked to review a specific chapter in the report based on their expertise. However, if they felt qualified, reviewers were invited to comment on other chapters, including the executive summary. A few reviewers commented on more than one chapter.

Peer review comments were collated into tables tied to the chapters in the draft SAP 3.4 material. After the peer review period ended, authors for each chapter met to deliberate the peer review comments. The full author Committee (a Federal Advisory Committee comprised of all the authors of chapters in the draft report product) subsequently convened a teleconference at which time the Chapter Lead Authors summarized and discussed the major peer review comments and their proposed responses. The final authors' responses were inserted in a corresponding section of the tables containing the peer reviewers' comments.

Note that while peer reviewer names are made public, attribution of specific comments to specific reviewers is not. The Reviewer ID numbers in the comment-response tables were randomly assigned.
