# Fire Forces Shut Marathon's St. James-to-Garyville, Louisiana Oil Pipeline March 10 Company's 256,000 Garyville, Louisiana Refinery to Tap On-Site Inventories

A late-morning explosion killed one worker, injured three others, and forced shut Marathon's St. James-to-Garyville, Louisiana oil pipeline March 10. The affected line delivers oil from the Louisiana Offshore Oil Port's LOCAP pipeline to Marathon's 256,000 b/d Garyville, Louisiana refinery. Marathon said the Garyville refinery would tap on-site inventories to remain in operation, but did not indicate whether it would, or had, slowed production. The company did not say when the line would return to service. The blast occurred at around 11:30 AM local time, as the four men welded on a pipe attached to a sump tank. There was no subsequent fire. The work was associated with Marathon's plans to expand Garyville's capacity by 180,000 b/d.

#### **Update: Supertanker Completes Crude Offloading in U.S. Gulf of Mexico March 10**

The punctured SKS Satilla offloaded approximately 976,190 barrels of oil onto other tankers in the U.S. Gulf of Mexico from March 8-to-March 10, the U.S. Coast Guard said. The tanker began taking on water on March 6, and underwater inspectors found punctures along the ship's external portside hull, sources reported. An investigation is ongoing at to the cause of the damage, but initial reports suggested that the tanker may have struck a sunken drilling unit. #### Update: Saudi Arabia to Open 1.2 Million b/d Khurais Oilfield by End of 2009

State-oil company Saudi Aramco completed drilling on its massive Khurais project, and said today that it planned to open the field by the end of 2009. The company had expected drilling to take three years, but workers finished that task 10 months ahead of schedule. The Khurais project will produce 1.2 million b/d of oil from three fields: Khurais, Abu Jifan and Mazalij. It will boost Saudi Arabia's output capacity to 12.5 million b/d. # Update: ConocoPhillips, BP Expect 2019 Start Date for Proposed 2 Bcf/d, 2,000-mile, Alaska-to-Alberta, Canada Natural Gas Pipeline

ConocoPhillips and BP expect to begin accepting transportation bids in 2010, and open the massive, 2,000-mile, 2 Bcf/d North Slope, Alaska-to-Alberta, Canada natural gas pipeline by 2019, a ConocoPhillips official said today. The companies may extend the pipeline 1,500 miles further, from Alberta, Canada to Chicago, Illinois. TransCanada has submitted a competing proposal to build a similar line. Only one of the two would likely come online.

#### Obama Approves DOE Budget for Fiscal 2009 March 11

President Obama today approved \$27 billion in funding for the U.S. Department of Energy's (DOE) fiscal year 2009 budget, sources reported. The U.S. House of Representatives and Senate passed the budget—part of the government's \$410 billion fiscal 2009 appropriations bill—on February 25 and March 10, respectively. The DOE figure marks a \$2.5 billion increase from fiscal 2008. Included in the plans are sharp spending increases toward programs in renewable energy, energy efficiency, science and environmental cleaning, and spending cuts for programs in nuclear energy and the Strategic Petroleum Reserve.
