1.0 Introduction:

The 2007 Peter Pan Fleet Co-Op was allocated 17,564.73 mt (see Table 1-A) of the Inshore component of the BSAI 2007 pollock TAC.

The individual catcher vessels belonging to the PP Fleet CoOp were given individual percentages of the Co-Op's allocation based on (confirmed by NMFS) historical catch brought to the PP Fleet CoOp.

This is showed in Table 1-B.

Using information on historical catch history percentages, table 1-C shows you how pollock allocations were given for the entire year.
