Indicators of Domestic Primary Metals, Steel, Aluminum, and Copper Activity

February 2009

The primary metals leading index started the year with a strong increase, however its 6-month smoothed growth rate is still deeply negative. The growth rate is indicating that U.S. primary metals industry activity growth may have a long road to recovery. The metals price leading index edged up, but its negative growth rate is suggesting more declines in metal prices.

The primary aluminum and the aluminum mill products indexes are suspended because of discontinued availability of industry-specific historical data. The USGS will continue to calculate the steel and copper composite indexes.

The **primary metals leading index** increased 2.0% to 128.9 in January from a revised 126.4 in December, and its 6-month smoothed growth rate moved up to -18.8% from a revised -23.4% in December. The 6-month smoothed growth rate is a compound annual rate that measures the near-term trend. Normally, a growth rate above +1.0% signals an upward trend for future growth in metals activity, while a growth rate below -1.0% indicates a downward trend. The Institute for Supply Management's PMI made the largest positive contribution, 1.0 percentage point, to the net increase in the primary metals leading index. However, the PMI is hovering around the level last experienced during the 1981-82 recession, and it is indicating further declines in future manufacturing activity. An increase in the JOC-ECRI metals price index growth rate contributed 0.6 percentage points. The stock price index combining construction and farm machinery companies and industrial machinery companies rose for the second consecutive month, buoying the leading index another 0.5 percentage points. In contrast, a slightly shorter average workweek in primary metals establishments contributed -0.2 percentage points to the leading index. Only four of the leading index's eight components were available for the January index calculation. The primary metals leading index will likely be revised next month when the remaining four components become available.

The U.S. recession has weakened domestic metals demand. The construction and manufacturing sectors have steadily declined to previous recession levels. Slowdowns in many other industrial-

ized economies, as well as emerging economies, have also eroded metals demands. The leading index, along with other recent U.S. economic data, indicates that the decline in U.S. primary metal activity is likely to continue. However, Government stimulus programs could boost metals demand in the months to come.

The **steel leading index** increased 2.2% in December, the latest month for which it is available, to 101.9 from a revised 99.7 in November. Its 6-month smoothed growth rate increased to -18.9% from a revised -24.2% in November. Movement among its nine indicators was mixed. The sharp increase in the inflation-adjusted M2 money supply growth rate, reflecting Government stimulus efforts, made the largest positive contribution to the net increase in the steel leading index. A rebound in the S&P stock price index for steel companies and longer weekly hours in iron and steel plants also made sizable positive contributions. In contrast, declines in the PMI and the index for new housing units authorized offset some of those gains. The steel leading index growth rate is indicating further declines in activity growth in the U.S. steel industry in the near term.

The **copper leading index** decreased 1.5% to 108.5 in December from a revised 110.1 in November. Its growth rate decreased to -19.4% from a revised -18.5% in November. Four of its six indicators declined, with the largest decrease coming from a sharp decline in the copper price. Fewer new housing permits issued and a closer yield spread between the U.S. 10-year Treasury Note and the federal funds rate also pulled the copper leading index down. In stark contrast, a rebound in the S&P

stock price index for building products companies in December made the largest positive contribution. The copper leading index growth rate is indicating further activity growth declines in the U.S. copper industry in the near term.

Rising Inventories Stifle Metals Price Growth

The **metals price leading index** edged up 0.1% to 101.9 in December, the latest month for which it is available, from a revised 101.8 in November. Its 6-month smoothed growth rate rose to -5.3% from a revised -6.2% in November. Two of its three available indicators increased. However, the increase in the growth rate of the inflation-adjusted value of new orders for U.S. nonferrous metal products was so slight that its contribution rounded to zero. The growth rate of the index measuring the trade-weighted average exchange value of other major currencies against the U.S. dollar made the largest positive contribution, 1.3 percentage points. In contrast, the contribution from a closer yield spread between the U.S. 10-year Treasury Note and the federal funds rate in December was -1.2 percentage points. The

fourth index component, the growth rate of the Economic Cycle Research Institute's (ECRI) 19-Country Long Leading Index, was only available through November. It improved only slightly and is indicating further declines in many global economies. The ECRI 19-Country Long Leading Index signals changes in the growth of economic activity in major countries about 5 months in advance.

The growth rate of the inflation-adjusted value of inventories of U.S. nonferrous metal products, which is an indicator of metals supply, continued to rise and reached a new recent high. This surge in metal stocks and the negative metals price leading index growth rate indicate further declines in metals price growth in the near future.

The business cycle and inventories are only two factors in metals price determination. Other factors that affect prices include changes in metals production, speculation, strategic stockpiling, foreign exchange rates, geopolitical instability, and production costs.

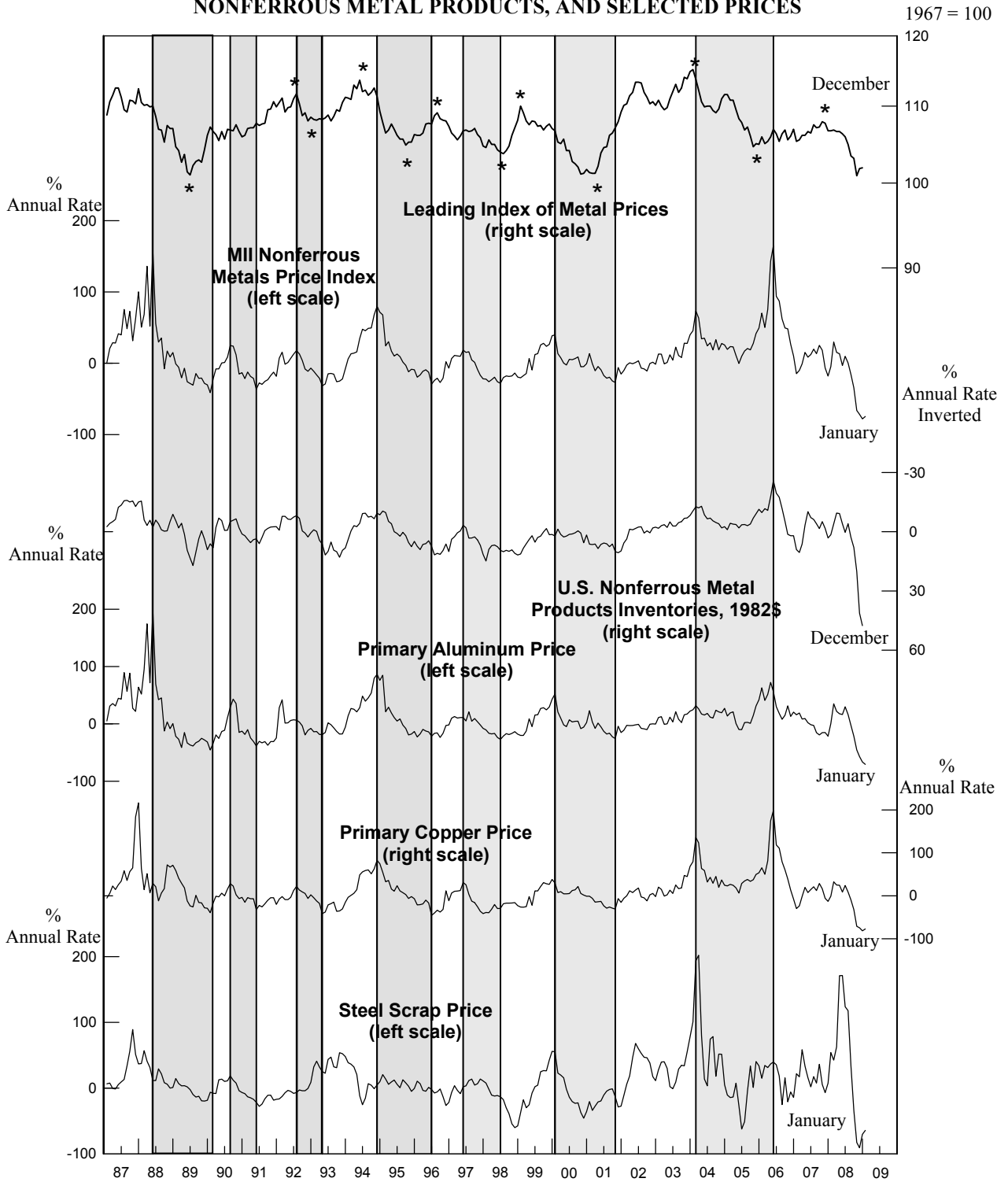

Note: The components of the Leading Index of Metal Prices are the spread between the U.S. 10-year Treasury Note and the federal funds rate, and the 6-month smoothed growth rates of the deflated value of new orders for nonferrous metal products, the Economic Cycle Research Institute's 19-Country Long Leading Index, and the reciprocal of the trade-weighted average exchange value of the U.S. dollar against other major currencies. The Metal Industry Indicators (MII) Nonferrous Metals Price Index measures changes in end-of-the-month prices for primary aluminum, copper, lead, and zinc traded on the London Metal Exchange (LME). The steel scrap price used is the price of No. 1 heavy melting. Inventories consist of the deflated value of finished goods, work in progress, and raw materials for U.S.-produced nonferrous metal products (NAICS 3313, 3314, & 335929). Six-month smoothed growth rates are based on the ratio of the current month's index or price to its average over the preceding 12 months, expressed at a compound annual rate.

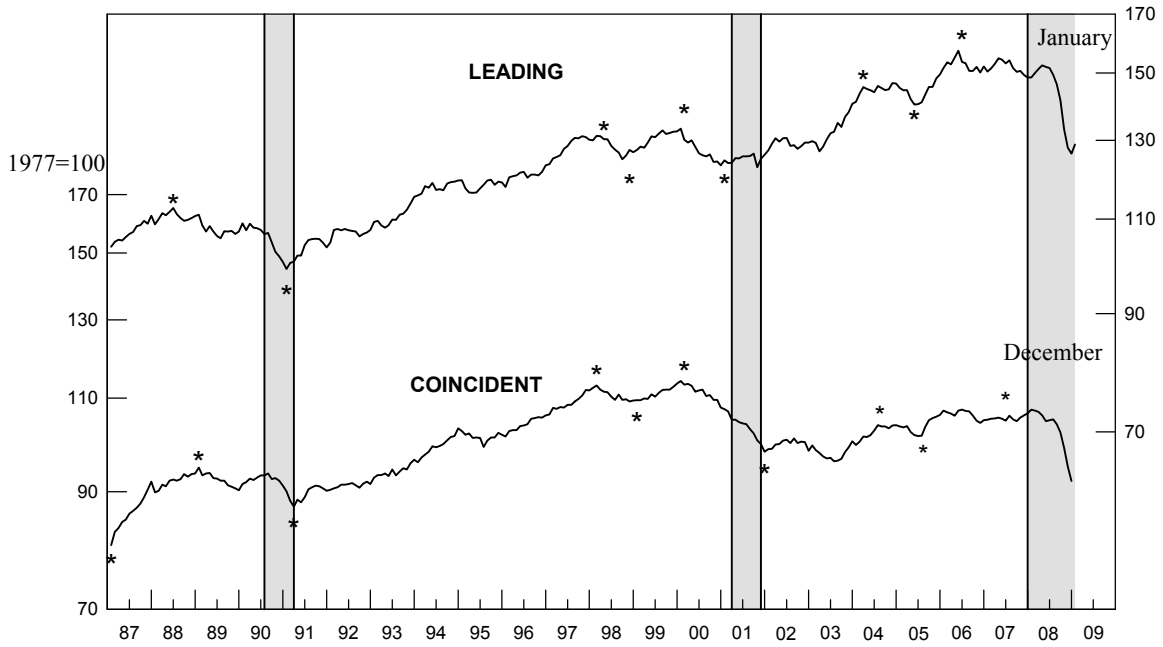

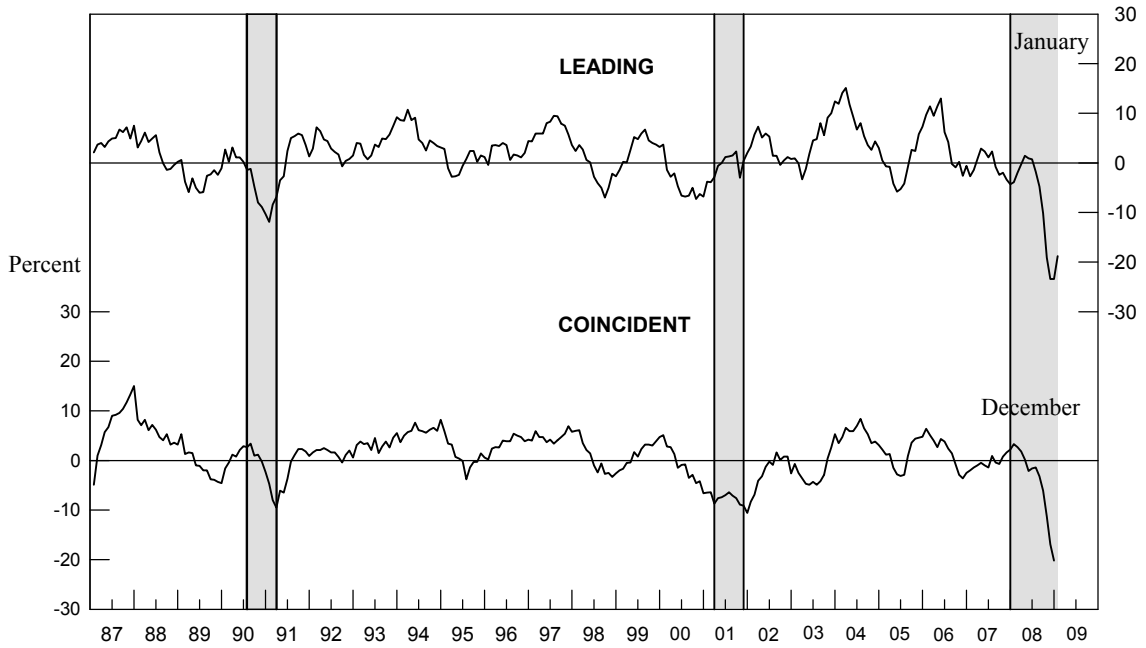
PRIMARY METALS: LEADING AND COINCIDENT INDEXES, 1987-2009 1977=100

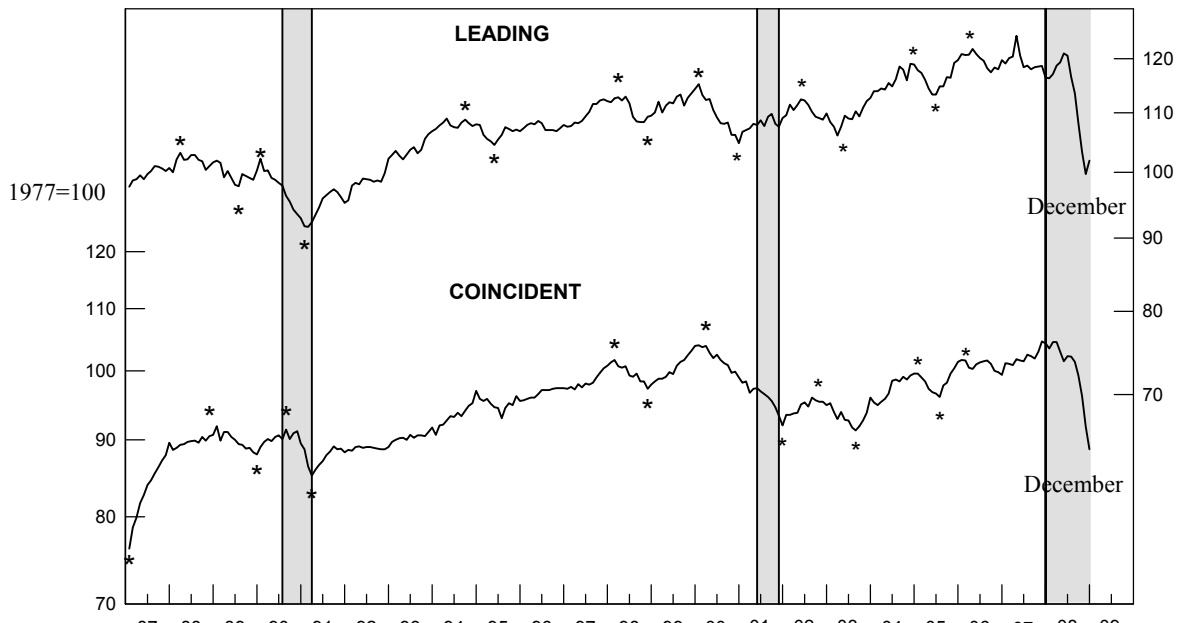

STEEL: LEADING AND COINCIDENT INDEXES, 1987-2008

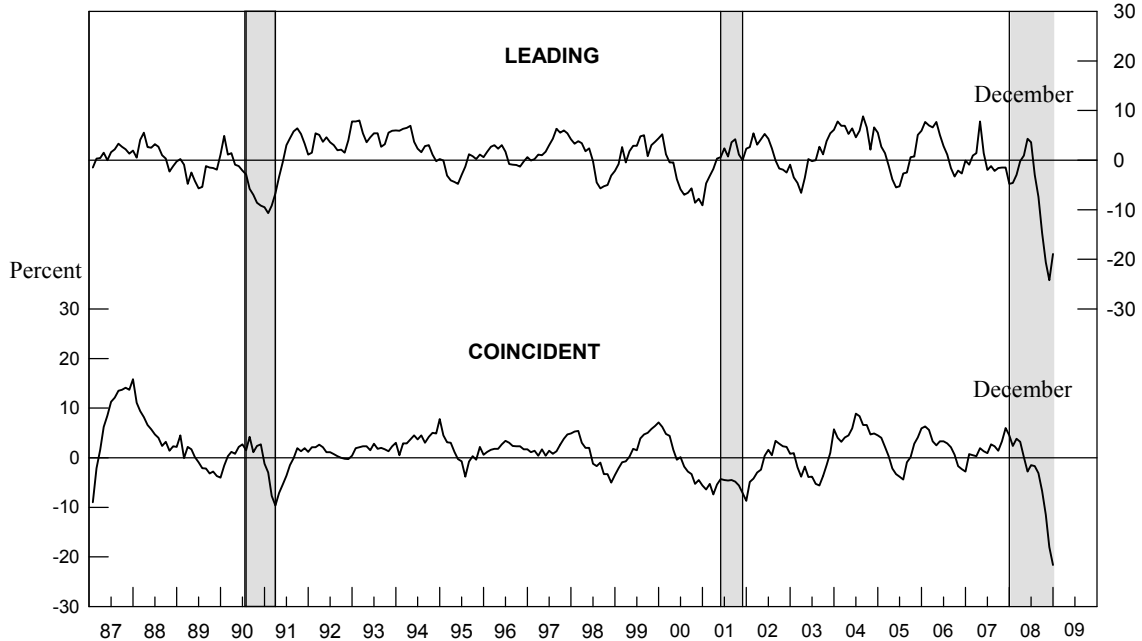

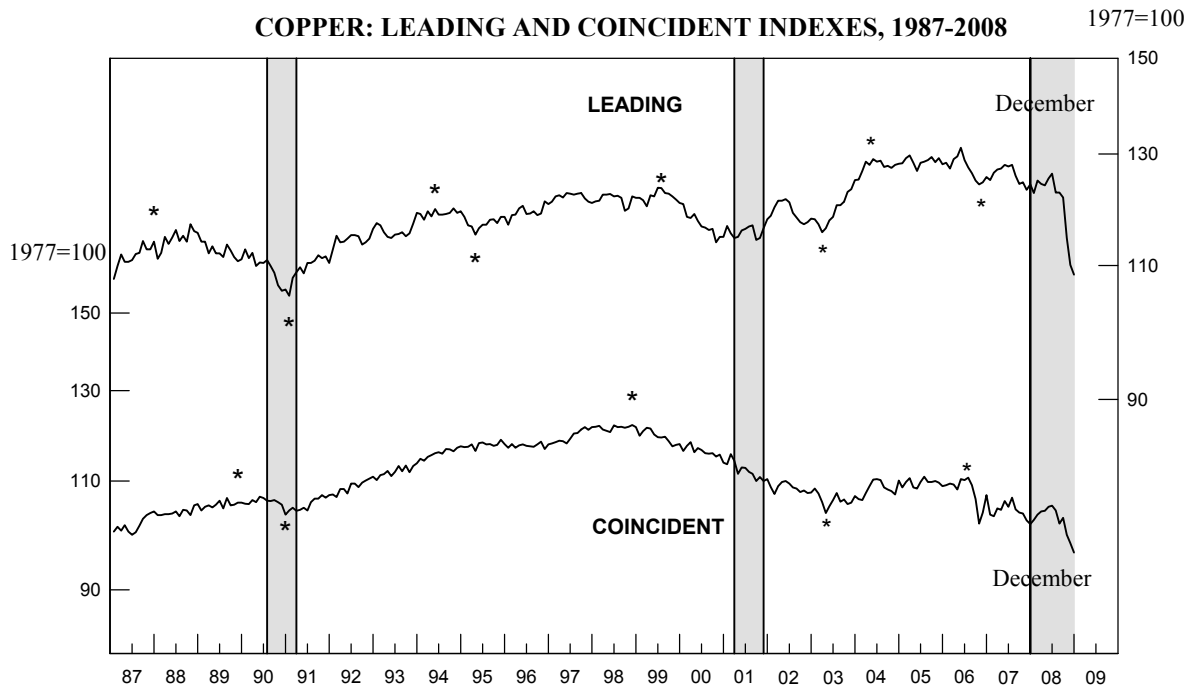

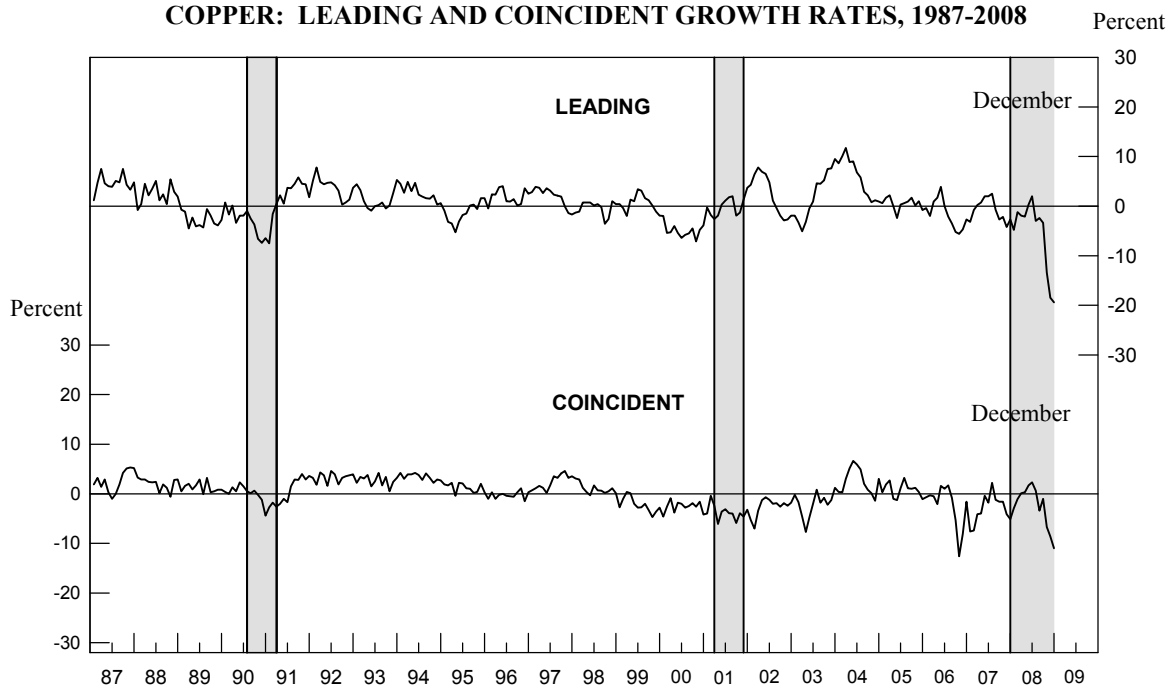

Explanation

Each month, the U.S. Geological Survey tracks the effects of the business cycle on five U.S. metal industries by calculating and publishing composite indexes of leading and coincident indicators. Wesley Mitchell and Arthur Burns originated the cyclical-indicators approach for the economy as a whole at the National Bureau of Economic Research in the mid-1930s. Over subsequent decades this approach was developed and refined, mostly at the National Bureau, under the leadership of Geoffrey H. Moore.¹

A business cycle can briefly be described as growth in the level of economic activity followed by a decline succeeded by further growth. These alternating periods of growth and decline do not occur at regular intervals. Composite indexes, however, can help determine when highs and lows in the cycle might occur. A composite index combines cyclical indicators of diverse economic activity into one index, giving decision makers and economists a single measure of how changes in the business cycle are affecting economic activity.

The indicators in the metal industry leading indexes historically give signals several months in advance of major changes in a coincident index, a measure of current metal industry activity. Indicators that make up the leading indexes are, for the most part, measures of anticipations or new commitments to various economic activities that can affect the metal industries in the months ahead.

Composite coincident indexes for the metal industries consist of indicators for production, shipments, and total employee hours worked. As such, the coincident indexes can be regarded as measures of the economic health of the metal industries.

The metal industry coincident indexes reflect industry activity classified by the U.S. Standard Industrial Classification (SIC) and the North American Industry Classification System (NAICS). Of the five metal industries, primary metals (NAICS 331) is the broadest, containing 25 different metal processing industries. Steel, aluminum, and copper are specific industries within the primary metals group.

The SIC was the main vehicle used by the U.S. Government and others in reporting industry economic statistics throughout most of the last century. Starting with the 1997 U.S. Economic Census, the U.S. Government began using the NAICS, which classifies economic data for industries in Canada, Mexico, and the United States. In general, metal industry indexes starting in 1997 begin to reflect the NAICS classification, while indexes for earlier years follow the SIC. Hence, composite indexes from 1997 forward are not entirely consistent with those of earlier years.

The largest change to primary metals because of the NAICS deals with other communication and energy wire manufacturing (NAICS 335929). Under NAICS, this manufacturing has been removed from primary metals and added to electrical equipment, appliance, and component manufacturing. Because monthly shipments and new orders for this wire are not available, the USGS is estimating their values from 1997 onward and adding them to the appropriate metal industry indicators and indexes to maintain consistency.

There are other small changes to the primary metals industry because of the switch to the NAICS. Coke oven activity not done by steel mills, for example, is removed and alumina refining, a part of industrial inorganic chemical manufacturing under the SIC, is added. Since the historic trends of the composite indexes are not affected by these small changes, the USGS is not making specific adjustments to the indexes for them for the periods before and after 1997.

The metal industry leading indexes turn before their respective coincident indexes an average of 8 months for primary metals and 7 months for steel and copper. The average lead time for the primary aluminum leading index is 6 to 8 months, and the average lead time for the aluminum mill products leading index is 6 months.

The leading index of metal prices, also published in the *Metal Industry Indicators*, is designed to signal changes in a composite index of prices for primary aluminum, copper, lead, and zinc traded on the London Metal Exchange. On average, this leading index indicates significant changes in price growth about 8 months in advance.

The growth rate used in the *Metal Industry Indicators* is a 6-month smoothed growth rate at a compound annual rate, calculated from a moving average. Moving averages smooth fluctuations in data over time so that trends can be observed. The 6-month smoothed growth rate is based upon the ratio of the latest monthly value to the preceding 12-month moving average.

$$\left[\left(\frac{\text{current value}}{\text{preceding 12-month moving average}} \right)^{\frac{12}{6.5}} - 1.0 \right] * 100$$

Because the interval between midpoints of the current month and the preceding 12 months is 6.5 months, the ratio is raised to the 12/6.5 power to derive a compound annual rate.

The growth rates measure the near-term industry trends. They, along with other information about the metal industries and the world economy, are the main tools used to determine the outlook of the industries. A 6-month smoothed growth rate above +1.0% usually means increasing growth; a rate below -1.0% usually means declining growth.
