# Marital Status and Living Arrangements: March 1997 (Update)

### DATA HIGHLIGHTS

Detailed tabulations are now available which provide statistics on the marital status and living arrangements of people in the United States, based on the March 1997 Current Population Survey. These tables provide information such as:

- In 1997, 109.2 million adults (55.9 percent of the adult population) were married and living with their spouse.
- The median age at first marriage was 26.8 years for men and 25.0 years for women.
- Among people age 25 to 34 years old, 13.9 million had never been married, representing 34.5 percent of all people in the age group. For Blacks in this age group, 54.2 percent had never been married.
- In 1997, 19.3 million adults were currently divorced, representing 9.9 percent of this population.
- Nearly half (46.3 percent) of women 65 years old and over were widowed. Of the elderly widows, 70 percent lived alone.
- There were 4.1 million unmarried couple households. Over one-third of these households (35.6 percent) had children under 15 present.
- About 19.8 million children under 18 lived with one parent (27.9 percent of all children under 18).
- The majority of children who lived with a single parent in 1997 lived with their mother (84.5 percent). About 40 percent of these children lived with mothers who had never been married. Children who lived with their father only were more likely to be living with a divorced father (45.1 percent).
- In 1997, 20.7 percent of married-couple households were women. Before 1980, the husband was always designated as the householder.

### DETAILED TABULATIONS

The tables include 9 detailed tables (75 pages), 12 historical tables, 3 summary tables, and 1 state table, and provide demographic characteristics on the marital status of the population and on the living arrangements of children and adults. The electronic version of these tables is available on the Internet in portable document format using the Adobe Acrobat reader, at the Census Bureau's World-Wide Web site (<http://www.census.gov>). Once on the site, click on "Subjects A-Z", then on "M" for Marital Status.
