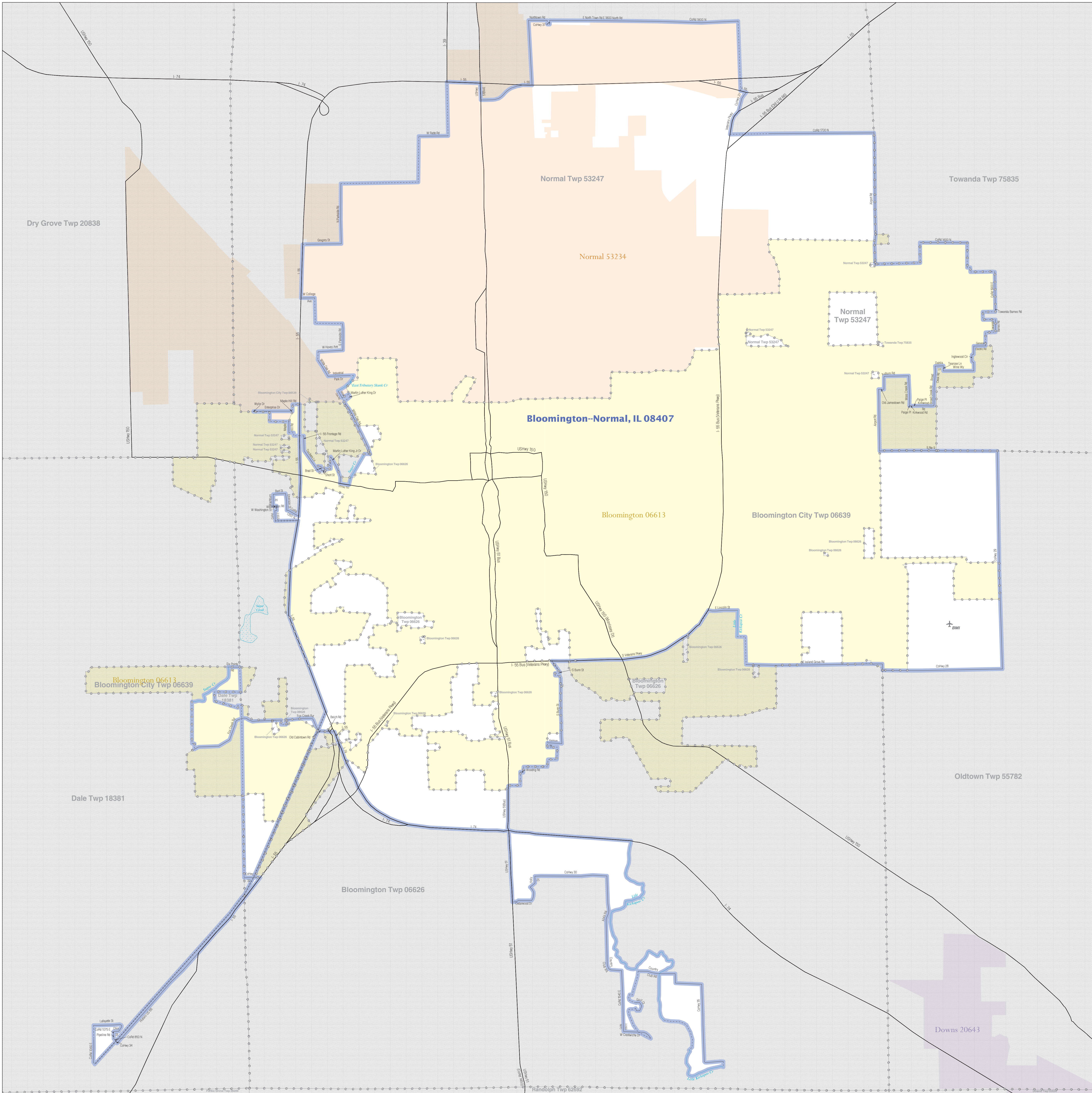


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) Bloomington--Normal, IL
