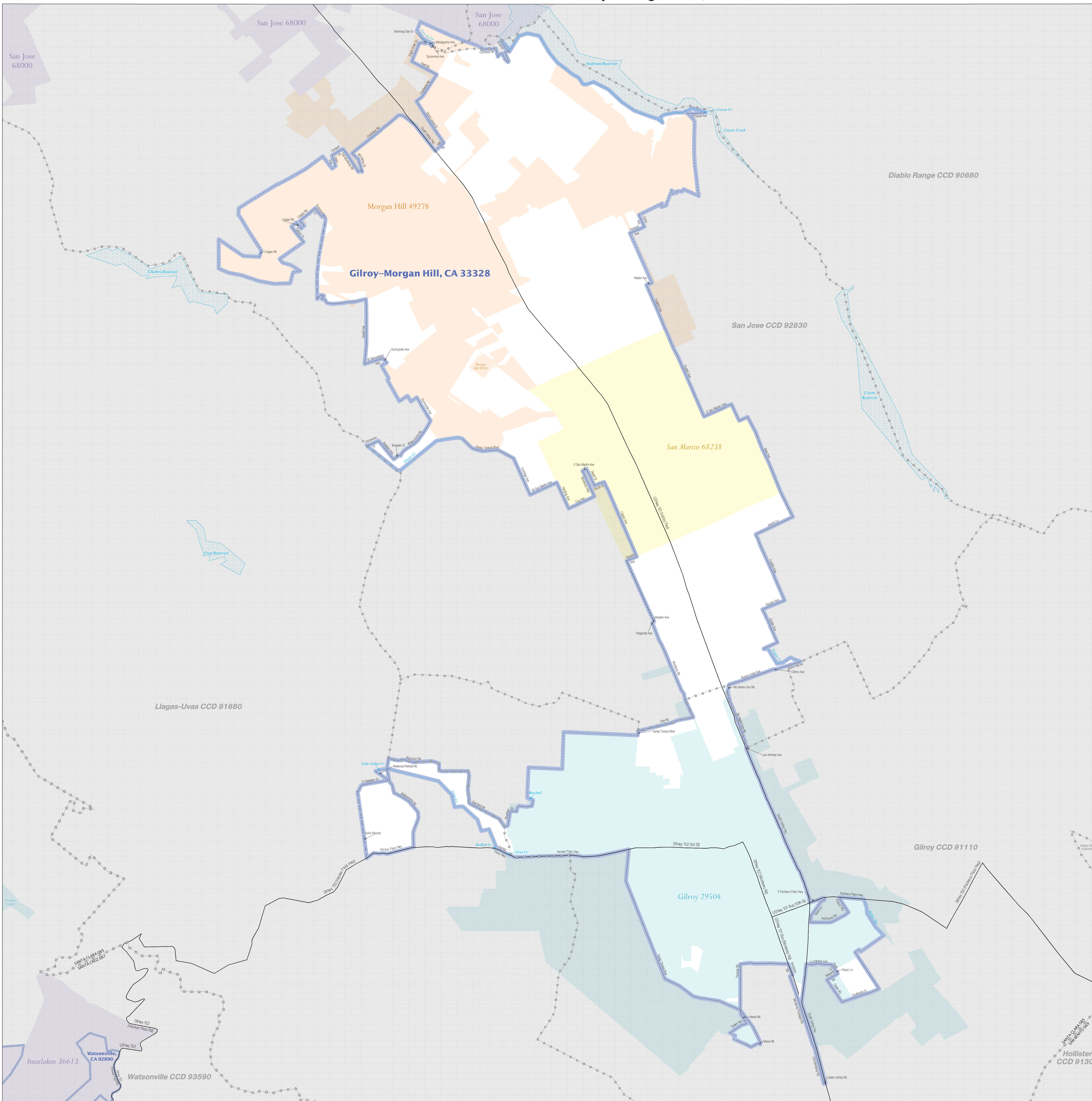


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) Gilroy--Morgan Hill, CA
