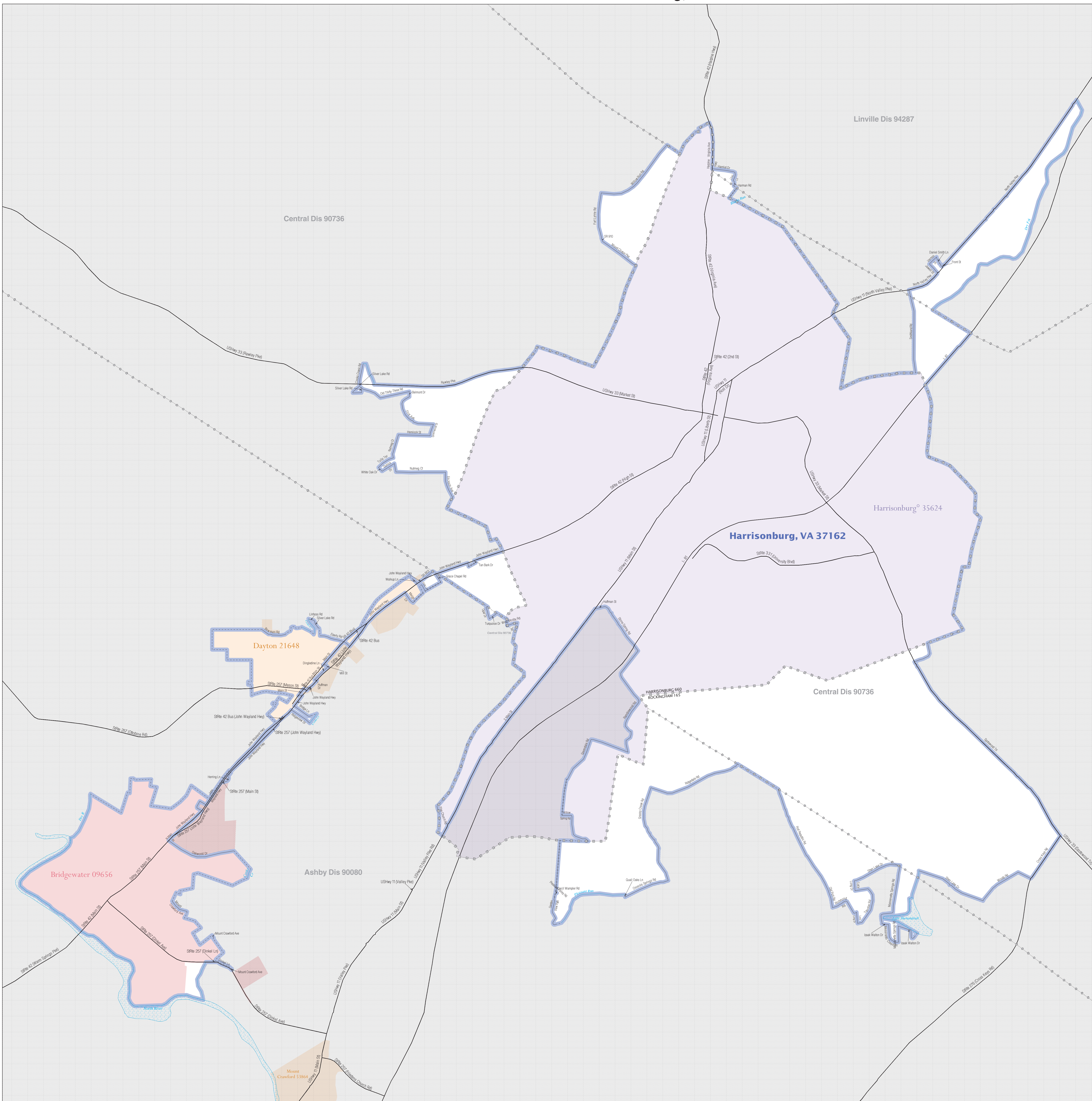


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) Harrisonburg, VA
