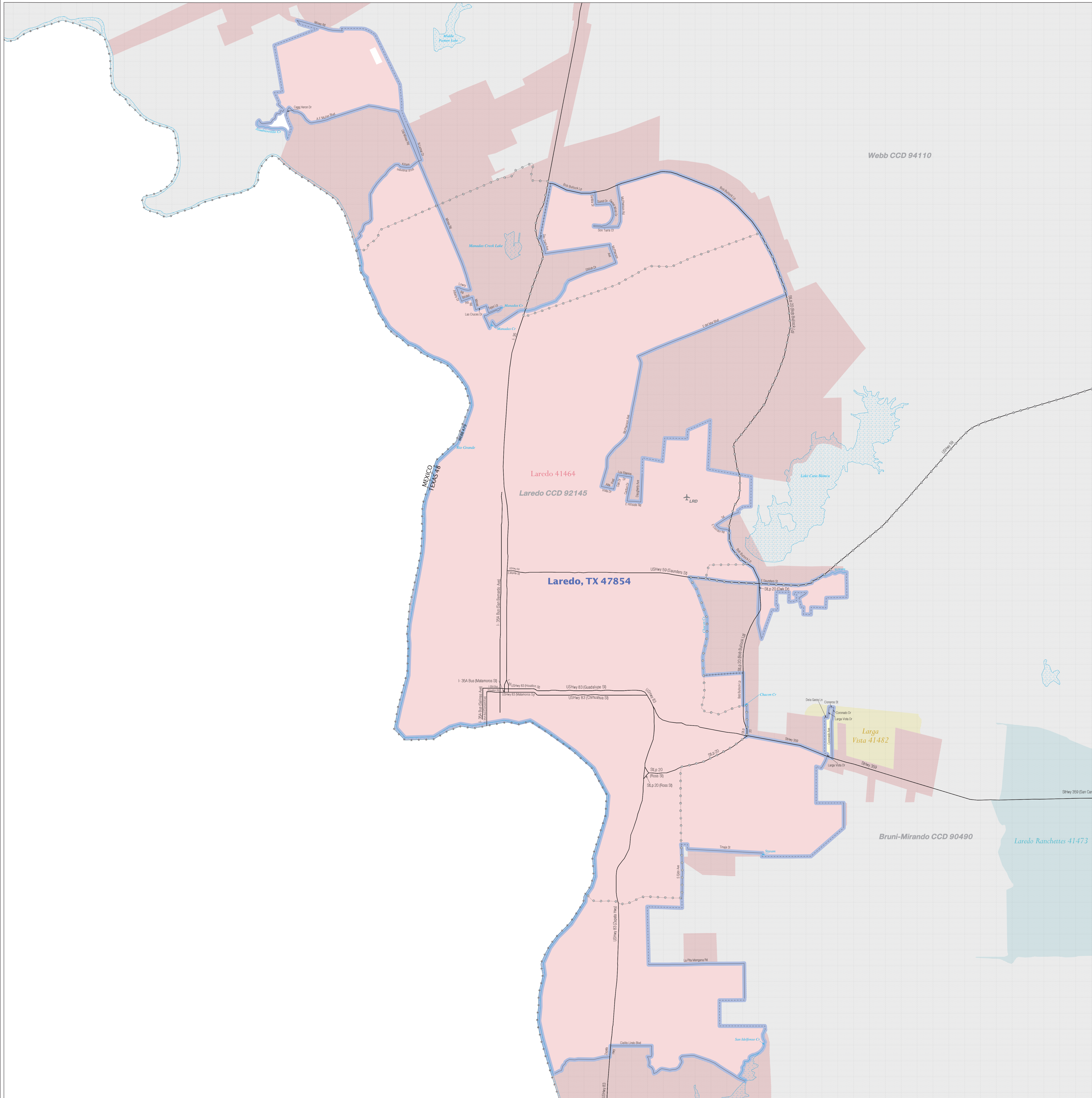


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) Laredo, TX
