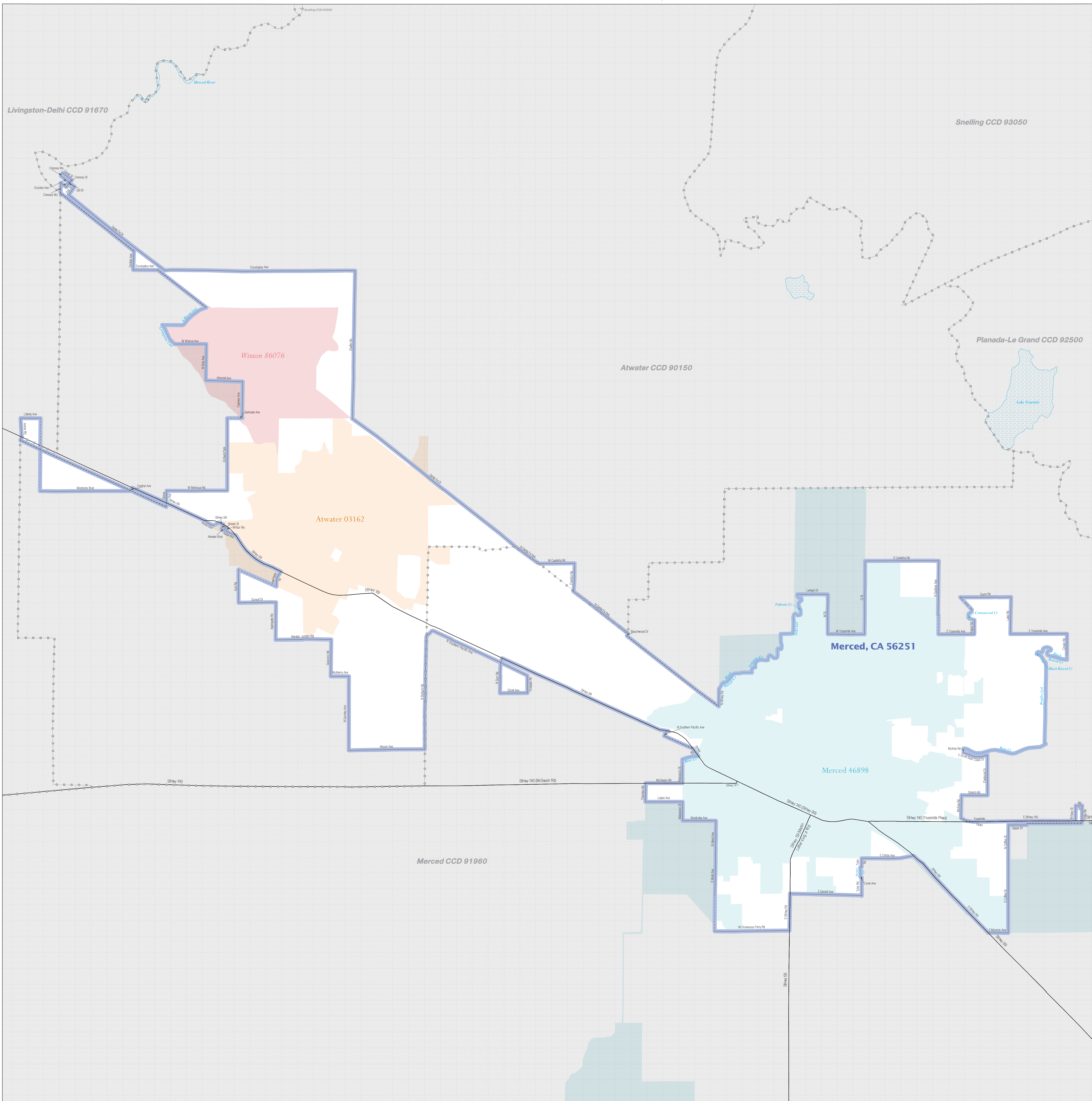


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) Merced, CA
