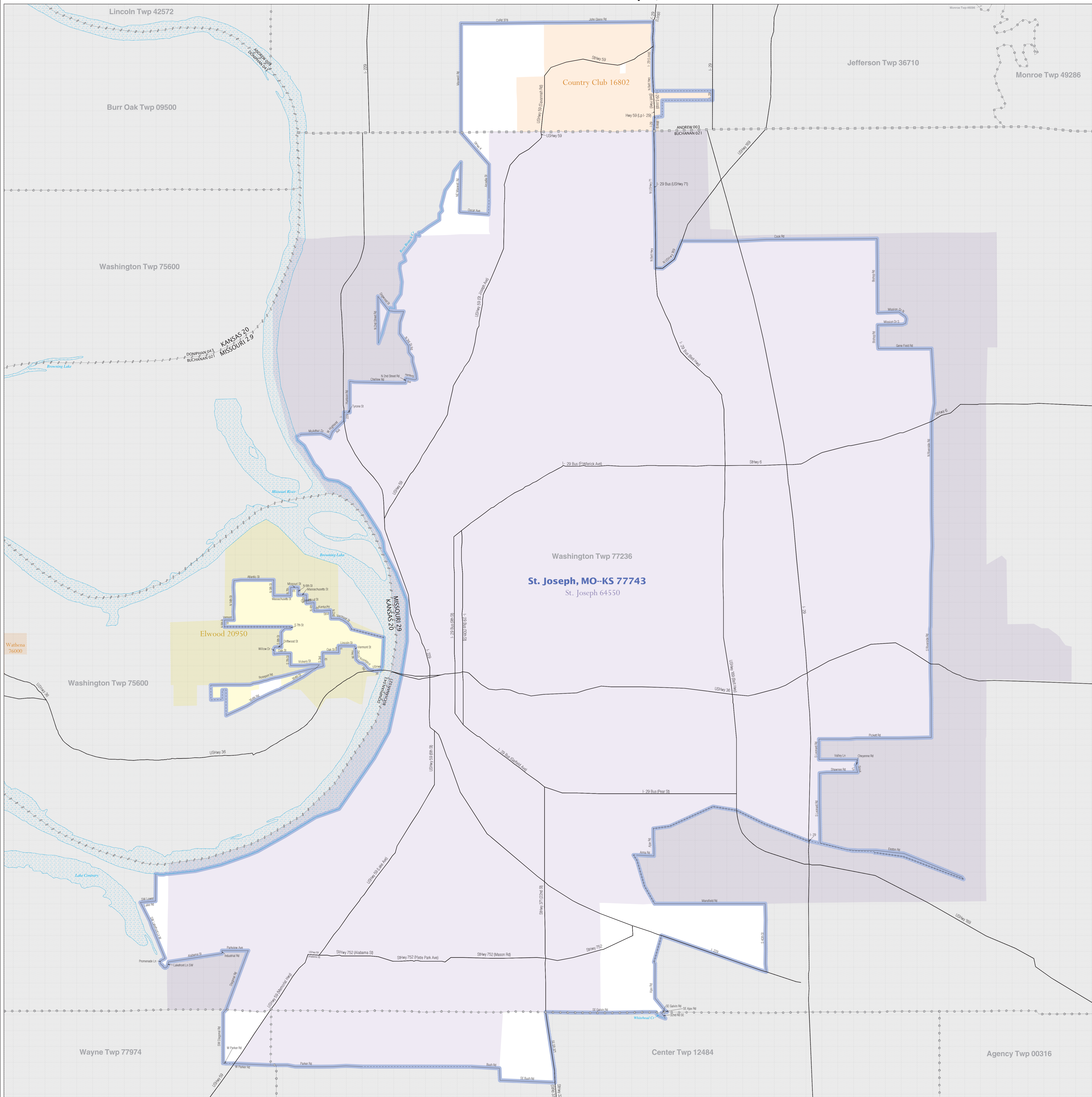


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) St. Joseph, MO--KS
