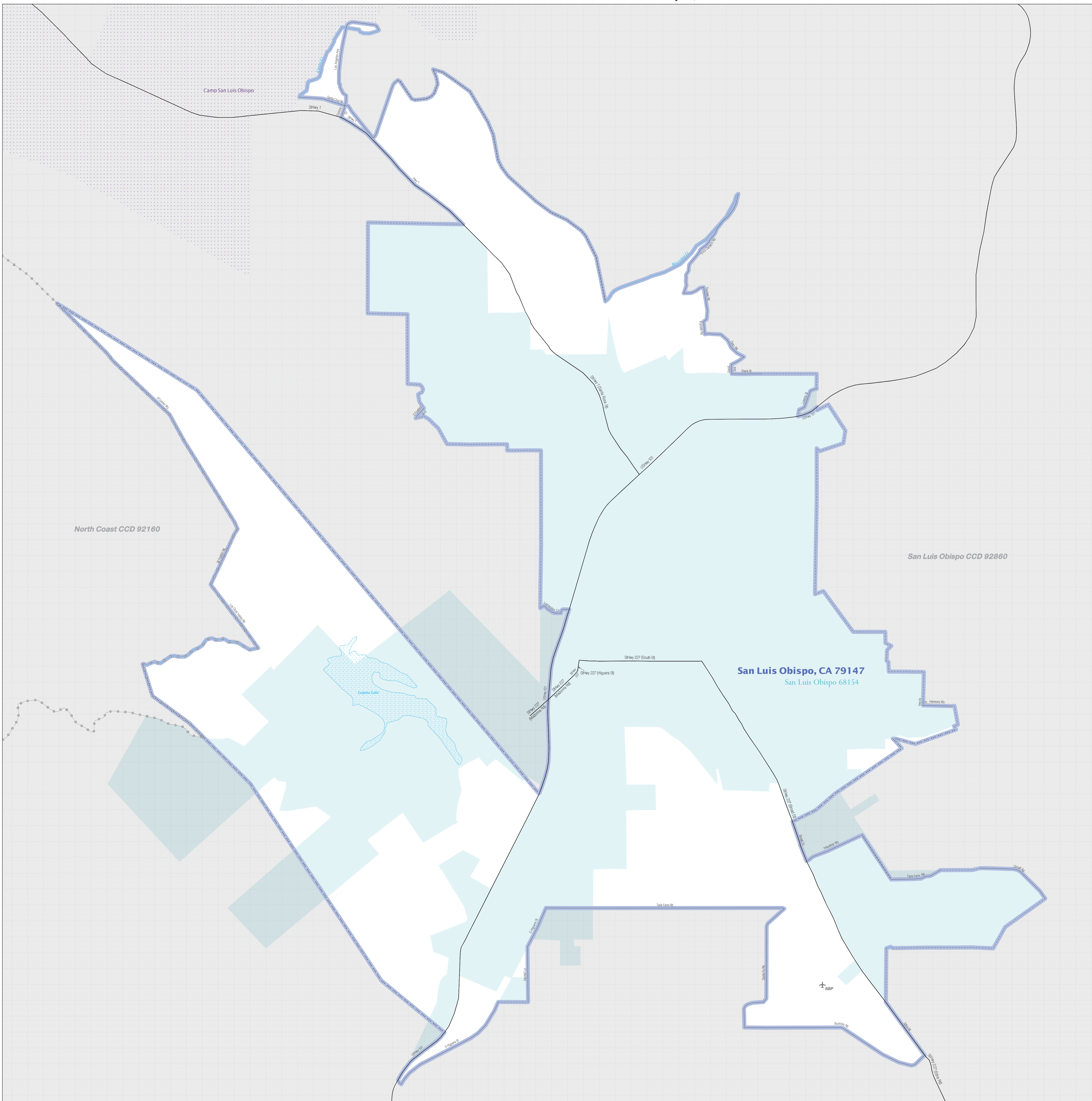


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) San Luis Obispo, CA
