#### ADMINISTRATIVE PROCEEDINGS

#### ADMINISTRATIVE PROCEEDINGS AGAINST LYNN DICKINSON

The Commission announced that on January 10 administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) were instituted against Lynn F. Dickinson. Simultaneously with the institution of these proceedings, the Commission accepted Dickinson's Offer of Settlement in which she consented to the entry of an order permanently barring her from association with any broker, dealer, municipal securities dealer, investment adviser or investment company.

The administrative proceedings were based upon the entry of an injunction on August 23, 1991, by the U.S. District Court for the Northern District of California against Dickinson, among others, prohibiting future violations of Section 17(a) and of Rule 10b-5 thereunder. Dickinson was also prohibited from committing future violations of Section 10(b) of the Exchange Act, Rule 10b-5 thereunder and Sections 203, 206(1), (2) and (4) of the Investment Advisers Act of 1940 and Rule 206(4)-2 thereunder. The conduct alleged in that action occurred during the period 1987 through June 28, 1991 while Dickinson was associated as a registered representative with a broker-dealer registered with the Commission. # SELF-REGULATORY ORGANIZATIONS

## APPROVAL OF PROPOSED RULE CHANGES

The Commission has approved a proposed rule change (SR-CBOE-91-39) filed by the Chicago Board Options Exchange which modifies the CBOE's disciplinary procedures. The procedures are modified by, among other things, providing for a 120-day period in which a respondent in a disciplinary proceeding may submit settlement offers and by limiting to two the number of settlement offers which a respondent may make during the 120-day period. Publication of the proposal is expected in the Federal Register during the week of January 20. (Rel. 34-30186)

The Commission has approved proposed rule changes submitted by the <u>Midwest Stock Exchange</u> (SR-MSE-90-40), <u>New York Stock Exchange</u> (SR-NYSE-90-8), <u>Philadelphia Stock Exchange</u> (SR-Phlx-90-27) and <u>Pacific Stock Exchange</u> (SR-PSE-90-12) to list warrants based on the Nikkei Stock Price Average (Nikkei). Additionally, the Commission approved a proposed rule change submitted by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-90-27) to list warrants based on the Tokyo Stock Price Index (TOPIX). Publication of the order is expected in the <u>Federal Register</u> during the week of January 20. (Rel. 34-30256)

#### JOINT INDUSTRY PLAN

The <u>Chicago Board Options Exchange</u>, <u>American Stock Exchange</u>, <u>New York Stock Exchange</u> and <u>Pacific Stock Exchange</u> filed with the Commission a proposed Joint Industry Plan providing for the creation and operation of an Option Market Linkage. The filing was amended on April 29, 1991 when the signatories to the Plan submitted the Model Option Trade-Through Rule as Exhibit A to the Plan. Publication of the proposal is expected in the <u>Federal Register</u> during the week of January 20. (Rel. 34-30187)

#### PARTIAL APPROVAL OF PROPOSED RULE CHANGE

The Commission granted partial approval to a proposed rule change filed by the <u>Cincinnati Stock Exchange</u> (SR-CSE-91-4) to amend the Exchange's guarantee for public agency orders by providing that the size of the guarantee will be the lesser of 2,099 shares or the size of the national best bid or offer and providing that no order will be guaranteed unless, in its entirety, it is 2,099 shares or less. (Rel. 34-30188)

#### TEMPORARY APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved temporarily a proposed rule change filed by the <u>Midwest Stock Exchange</u> (SR-MSE-91-10) to adopt revised procedures for stopped orders in minimum variation markets. The Commission approved the proposal as a one-year pilot program. (Rel. 34-30189)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
