EXCHANGE COMMISSION

CHAIRMAN BREEDEN TO TESTIFY

Chairman Breeden will testify before the Subcommittee on Commerce, Justice, State, The Judiciary, and Related Agencies of the House Committee on Appropriations on March 18 at 2:00 p.m. in the U.S. Capitol Building in Room H310. The subject matter will be 1993 Appropriations.

ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS AGAINST JOSEPH JENKINS, JR. DISCONTINUED

At the request of the Division of Enforcement, which has been unable to effect service of the order for proceedings on Joseph Jenkins, Jr., formerly of Brooklyn, New York, the Commission has discontinued its proceedings against Jenkins, without prejudice to their re-institution on the basis of the same allegations. CIVIL PROCEEDINGS

JIMMIE STRAW AND OFFSHORE BANK PERMANENTLY ENJOINED

The Commission announced that on March 12 the Honorable Harold L. Murphy, U.S. District Judge of the Northern District of Georgia, entered an Order permanently enjoining Jimmie F. Straw (Straw) of Dalton, Georgia, and First American Bank, Limited (FABL) from future violations of the registration and antifraud provisions. Without admitting or denying the allegations in the Commission's complaint, the defendants consented to the Order which also appoints a receiver and continues a freeze of assets and other relief. The complaint alleges that since 1984, Straw and others raised over \$16 million by the fraudulent sale of unregistered securities to hundreds of investors throughout the U.S. Straw controlled FABL, an offshore bank licensed in the Commonwealth of the Northern Mariana Islands, a U.S. Territory, while another defendant acted as a finder for the sales of other securities called the Money School Club memberships. Many investors are retired persons living on fixed incomes. The staff acknowledges the assistance of the Alabama, Georgia and Virginia securities commissions in this matter. [SEC v. Jimmie F. INVESTMENT COMPANY ACT RELEASES

NORTH AMERICAN SECURITY TRUST, ET AL.

A notice has been issued giving interested persons until April 7 to request a hearing on an application filed by North American Security Trust (Fund) and three entities serving as subadvisers to certain of the Fund's portfolios for an order under Section 6(c) of the Investment Company Act. The order would exempt applicants from Section 15(a) of the Act and permit the subadvisers to serve as such until the earlier of July 10, 1992 or the date of shareholder approval or disapproval of their respective subadvisory agreements. HOLDING COMPANY ACT RELEASES

THE COLUMBIA GAS SYSTEM, INC.

A notice has been issued giving interested persons until April 6 to request a hearing on a proposal by The Columbia Gas System, Inc. (Columbia), a registered holding company. Columbia proposes to sell its remaining 90.8% interest in the common stock of Columbia LNG Corporation (Columbia LNG) to Shell LNG Company (Shell LNG) for \$110 million. Also proposed is the repayment of all of Columbia LNG's outstanding debt to Columbia, certain indemnifications by Columbia and Columbia's repurchase of Shell LNG's Columbia LNG common stock interest if the sale is not consummated.
