ADMINISTRATIVE PROCEEDINGS INSTITUTED AND SANCTIONS IMPOSED AGAINST WELLSHIRE SECURITIES, INC., ROBERT COHEN AND CAROL MARTINO

The Commission instituted proceedings and imposed sanctions against Wellshire Securities, Inc., now a defunct penny stock brokerage firm, Robert Cohen, Wellshire's President, and Carol Martino, Wellshire's Executive Vice President. All of the above respondents consented to the findings and sanctions without admitting or denying the findings.

The Orders Instituting Proceedings, Making Findings and Imposing Remedial Sanctions allege that Wellshire, under the direction and control of Cohen and Martino, operated as a penny stock boiler room, selling speculative over-the-counter securities of unseasoned companies through the use of violative sales practices and misrepresentations. The Orders also allege that Wellshire and Cohen participated in the market manipulation of Ventura Inc. The Orders allege that Wellshire, Cohen and Martino violated the antifraud provisions of the federal securities laws.

The Orders revoked Wellshire's broker-dealer registration and barred Cohen and Martino from the securities industry. (Rel. 34-30543; 34-30544 and 34-30545)

HAROLD FISHER BARRED

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Harold L. Fisher of Sarasota, Florida. Simultaneously, the Commission accepted Fisher's Offer of Settlement. The Commission found that Fisher was convicted pursuant to a plea of guilty of violating the antifraud provisions of the securities laws in U.S. v. Harold L. Fisher, USDC, Colo. 91-CR-122 and was enjoined by consent in SEC v. Harold L. Fisher, Civil Action No. 92 0395, USDC D.D.C.

The Commission also found that Fisher's conviction and injunction were based on Fisher's participation with others to artificially increase the price of Monarch Acquisition's common stock through a series of prearranged trades between securities accounts controlled by the principals of Monarch and related persons.

The Commission's Order bars Fisher from association in any capacity with any broker, dealer, investment adviser, investment company or municipal securities dealer. (Rel. 34-30546)

NASD DISCIPLINARY ACTION AGAINST KEVIN WAIDE, LAWRENCE UNDERWOOD AND JOHN HARRIS SET ASIDE

The Commission has set aside NASD disciplinary action against Kevin B. Waide of Denver, Colorado, Lawrence M. Underwood of Aurora, Colorado and John N. Harris of Boulder, Colorado, former salesmen of First Financial Securities, Inc., formerly an NASD member firm. In so doing, the Commission prospectively clarified the method for calculating the markup in a transaction effected on a riskless principal basis, *i.e.*, where the retail dealer has purchased the securities from another dealer after already receiving its customer's purchase order. In such a transaction, the Commission determined that, normally, the dealer should base its markup on a price no higher than its cost, without regard to evidence that the wholesale market price is higher.

The Commission indicated that under the proper standard for riskless principal trades the prices charged applicants' customers were excessive because they greatly exceeded the firm's cost. However, the Commission applied the standard prospectively and held that under the circumstances no finding of violation should be made in the present case. (Rel. 34-30561)
