ADMINISTRATIVE PROCEEDINGS

NATIONAL INVESTMENT FUNDS, INC. AND ROBERT MAILEY SANCTIONED

The Commission has issued an Order Instituting Public Administrative Proceedings, Making Findings and Imposing Remedial Sanctions and Cease and Desist Order (Order) pursuant to Sections 15C(c)(1) and 21C(a) of the Securities Exchange Act of 1934 against National Investment Funds, Inc. (NIF), a government securities broker-dealer, and Robert J. Mailey (Mailey), president and owner of NIF. Simultaneously, the Commission accepted the Offer of Settlement (Offer) submitted by NIF and Mailey whereby they consented to the Order without admitting or denying the findings therein.

On the basis of the Order and NIF's and Mailey's Offer, the Commission found that NIF and Mailey willfully violated Sections 15C(a)(1)(A) and 15C(e)(1) of the Exchange Act by effecting transactions in U.S. Treasury Bills and Treasury Notes while NIF was not registered with the Commission and not a member of a registered national securities exchange or a registered securities association.

Based upon these findings and Offer, NIF and Mailey were ordered to permanently cease and desist from committing or causing any violation, and committing or causing any future violations of the above-referenced provisions. NIF and Mailey were also ordered to pay a civil penalty in the aggregate of \$5,000. (Rel. 34-30586)

PROCEEDINGS INSTITUTED AGAINST JAMES LAIACONA

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against James A. Laiacona (Laiacona) of Stuart, Florida, a former undisclosed control person of AAA Transfer Corporation (AAA Transfer). The Order for Proceedings alleges Laiacona financed operations of AAA Transfer and acted as an undisclosed control person. He aided and abetted AAA Transfer's failure to disclose his past securities laws violations. Laiacona caused AAA Transfer to improperly issue stock by causing an authorization letter to be forged. In addition, he has been enjoined from further securities laws violations by a federal court and criminally convicted of violations involving transactions in securities.

A hearing will be scheduled to determine whether the allegations against Laiacona are true, and, if so, what, if any, remedial sanctions are appropriate. (Rel. 34-30599)

PROCEEDINGS INSTITUTED AGAINST GENA LAIACONA

The Commission instituted public administrative proceedings pursuant to Section 17A(a)(4)(C) of the Securities and Exchange Act of 1934 (Exchange Act) against Gena Marie Laiacona (Laiacona) of Pompano, Florida, former vice-president, secretary and 50% shareholder of AAA Transfer Corporation (AAA Transfer), a transfer agent. The Order for Proceedings alleges Laiacona aided and abetted violations by AAA Transfer of Section 17A of the Exchange Act. Specifically, Laiacona aided and abetted AAA Transfer's failure to disclose the role of James A. Laiacona as a control person of AAA Transfer and source of financing for AAA Transfer. Laiacona also aided and abetted AAA Transfer's failure to amend AAA Transfer's filings when she became an officer and shareholder of AAA Transfer. In addition, Laiacona caused an authorization letter to be forged permitting the improper issuance of common stock by AAA Transfer. Laiacona has been enjoined by a federal court against further securities laws violations.

A hearing will be scheduled to determine whether the allegations against Laiacona are true, and, if so, what, if any, remedial sanctions are appropriate. (Rel. 34-30600)

PROCEEDINGS INSTITUTED AGAINST LINDA MARRIOTT

The Commission instituted public administrative proceedings pursuant to Section 17A(a)(4)(C) of the Securities and Exchange Act of 1934 (Exchange Act) against Linda James Marriott (Marriott) of Fort Worth, Texas, president and 50% shareholder of AAA Transfer Corporation (AAA Transfer), a transfer agent that was registered with the Commission until December 6, 1989.

The Order of Proceedings alleges that Marriott aided and abetted violations by AAA Transfer of the reporting provisions of the federal securities laws by making inaccurate and misleading filings on Form TA-1 and SEC Supplement. Also, she aided and abetted AAA Transfer's violations of Section 17A(d)(1) and Rule 17Ad-6(a)(8) by engaging in transfer agent activities for a company without obtaining and maintaining the necessary documentation authorizing AAA Transfer to act as its transfer agent.

A hearing will be scheduled to determine whether the allegations against Marriott are true, and, if so, what, if any, remedial sanctions are appropriate. (Rel. 34-30601)

INVESTMENT COMPANY ACT RELEASES

VARIABLE STOCK FUND, INC. SALOMON BROTHERS INSTITUTIONAL SERIES FUNDS INC

Orders have been issued under Section 8(f) of the Investment Company Act declaring that Variable Stock Fund, Inc. and Salomon Brothers Institutional Series Funds Inc have ceased to be investment companies. (Rel. IC-18660 - April 17 and IC-18662 - April 20, respectively)

SUNAMERICA CAPITAL APPRECIATION FUND, INC., ET AL.

A conditional order amending a prior order has been issued under Section 6(c) of Investment Company Act on an application filed by SunAmerica Capital Appreciation Fund, Inc. and other investment company applicants advised by SunAmerica Asset Management Corp. (SAAMCo) and distributed by SunAmerica Capital Services, Inc. (SACs), Wellington Management Company, SAAMCo and SACs. The conditional order permits the imposition of a contingent deferred sales charge arrangement. (Rel. IC-18661 - April 17)

HOLDING COMPANY ACT RELEASES

NATIONAL FUEL GAS COMPANY, ET AL.

An order has been issued authorizing National Fuel Gas Company (National), a registered holding company, and its wholly owned subsidiary company, National Fuel Gas Distribution Corporation (Distribution) to engage in financing. National proposes to issue and sell in one or more transactions through December 31, 1993 up to an aggregate principal amount of \$150 million of one or more series of its debentures (New Debentures), under the alternative competitive bidding procedures as modified by the Commission's Statement of Policy dated September 2, 1982 (HCAR No. 22623). The Commission shall reserve jurisdiction over the issuance and sale of up to \$150 million of medium-term notes (New MTNs) such that the aggregate principal amount of New Debentures and New MTNs will not exceed \$150 million. In addition, National proposes to lend the proceeds from the issuance of the New Debentures to Distribution in exchange for unsecured notes. (Rel. 35-25517)

GEORGIA POWER COMPANY

A notice has been issued giving interested persons until May 11 to request a hearing on a proposal by Georgia Power Company to create a program to provide a source of financing for residential, commercial and industrial consumers' acquisition and installation of weatherization products. (Rel. 35-25518)

WEST TEXAS UTILITIES COMPANY

A notice has been issued giving interested persons until May 11 to request a hearing on a proposal by West Texas Utilities Company (WTU), an electric public-utility subsidiary company of Central and South West Corporation, a registered holding company. WTU proposes to issue and sell first mortgage bonds (Bonds) in an aggregate principal amount of up to \$25 million, in one or more series from time to time through December 31, 1993 under an exception from the competitive bidding requirements of Rule 50 under Subsection (a)(5) thereunder. The Bonds may be issued pursuant to one or more deviations from the Commission's Statement of Policy Regarding First Mortgage Bonds Subject to the Public Utility Holding Company Act of 1935. WTU has been granted authorization to begin negotiations for the private placement of the Bonds. (Rel. 35-25518)

JERSEY CENTRAL POWER & LIGHT COMPANY

A notice has been issued giving interested persons until May 11 to request a hearing on a proposal by Jersey Central Power & Light Company (JCPL), an electric-utility subsidiary of General Public Utilities Corporation, a registered holding company. JCPL proposes, in connection with its sale of up to \$100 million aggregate stated value of cumulative preferred stock, to acquire such shares from time to time through a sinking fund or redemption provision and to amend its Certificate of Incorporation to allow for such issuance and sale of stock. (Rel. 35-25518)

MAINE YANKEE ATOMIC POWER COMPANY

A notice has been issued giving interested persons until May 11 to request a hearing on a proposal by Maine Yankee Atomic Power Company (Maine Yankee), an indirect publicutility subsidiary company of Northeast Utilities and of New England Electric System, both registered holding companies. The proposal seeks to amend Maine Yankee's Articles of Incorporation (Articles) to increase the number of authorized shares of cumulative preferred stock (Preferred Stock) from 170,000 shares to 260,000 shares. The proposal also seeks to issue and sell up to 200,000 shares of a new series of the Preferred Stock through December 31, 1992. Further, the proposal seeks to solicit Maine Yankee's shareholders in order to authorize the proposed amendment to the Articles and to consent to the issuance and sale of the new series of Preferred Stock. SELF-REGULATORY ORGANIZATIONS

TEMPORARY APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>American Stock Exchange</u> (SR-Amex-91-05) to amend Amex Rule 109 in order to permit a specialist, upon request, to grant a stop in a minimum fractional change market for any order of 2,000 shares or less, up to a total of 5,000 shares for all stopped orders, without obtaining prior Floor Official approval. A Floor Official, however, would be able to authorize a greater order size or aggregate share threshold. The Commission approved the proposal as a one-year pilot program. (Rel. 34-30603)
