CRIMINAL PROCEEDINGS

THREE PENNYCON DEFENDANTS FOUND GUILTY AND ONE ACQUITTED

The Commission and Michael J. Norton, U.S. Attorney for the District of Colorado, jointly announced that on September 23, 1992 Steven Sneed of Arlington, Virginia, Herman Graulich of Miami, Florida and Brent Gunderson of Salt Lake City, Utah were convicted of securities, mail and wire fraud stemming from an undercover sting called "Operation Pennycon." The individuals are awaiting sentencing. A fourth defendant, Sam Pandolfo of Denver, Colorado was acquitted.

The case resulted from a nearly two-year undercover investigation by the Colorado U.S. Attorney's Securities and Commodities Fraud Task Force. The ten-count indictment was issued April 3, 1991 naming ten defendants. Six entered guilty pleas prior to trial. After a superseding indictment was issued on May 8, 1992, the four remaining defendants went to trial. The indictment involving Monarch Acquisitions alleged a scheme to defraud by manipulating the price of Monarch Acquisitions' stock through controlled, prearranged purchases and sales of Monarch's stock. HOLDING COMPANY ACT RELEASES

ESI ENERGY INC., ET AL.

An order has been issued granting an exemption under Section 3(a)(5) from all provisions of the Public-Utility Holding Company Act, except Section 9(a)(2), to National Power Company (NPC), a closely-held California corporation. An exemption under Section 3(b) was also granted from all provisions of the Act to Power Barge Impedance, L.P., a California limited partnership (Impedance, L.P.), in connection with the proposal to acquire a public-utility subsidiary company that will operate and sell power exclusively outside of the United States. Impedance, L.P. will be an indirect subsidiary company of FPL Group, Inc., a public-utility holding company exempt from registration under Section 3(a)(1) pursuant to Rule 2. (Rel. 35-25654; International Series Rel. 474)

An order has been issued granting the application of the <u>New York Stock Exchange</u> to strike from listing and registration Mesa Offshore Trust, Units of Beneficial Interest. (Rel. 34-31325)

UNLISTED TRADING PRIVILEGES SOUGHT

Notices have been issued giving interested persons until November 5, 1992 to comment on the applications of three exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. The exchanges and number of issues are as follows: <u>Cincinnati Stock Exchange</u> - 21 issues (Rel. 34-31321); <u>Philadelphia Stock Exchange</u> - 15 issues (Rel. 34-31322); and <u>Pacific Stock Exchange</u> - 14 issues (Rel. 34-31323).

UNLISTED TRADING PRIVILEGES GRANTED

An order has been issued granting the application of the <u>Cincinnati Stock Exchange</u> for unlisted trading privileges in 37 issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The <u>National Securities Clearing Corporation</u> filed a proposed rule change (SR-NSCC-92-08) that will enable NSCC to facilitate the clearance and settlement of index receipt products such as the American Stock Exchange's Portfolio Depository Receipts. Publication of the proposal is expected in the <u>Federal Register</u> during the week of October 19. (Rel. 34-31318)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-NASD-92-29) filed by the <u>National Association of Securities Dealers</u> that amends Article III of the NASD Rules of Fair Practice. The rule change requires members to send periodic account statements at least once every quarter to customers having securities positions, funds or any change in their account during the past quarter. (Rel. 34-31319)

The Commission approved a proposed rule change (SR-GSCC-92-07) filed by the <u>Government Securities Clearing Corporation</u> that will allow GSCC to make certain enhancements to its comparison system. Publication of the proposal is expected in the <u>Federal Register</u> during the week of October 19. (Rel. 34-31328)

ACOUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
