ADMINISTRATIVE PROCEEDINGS

LESTER KUZNETZ BARRED

Administrative Law Judge Jerome K. Soffer issued an initial decision barring Lester Kuznetz, of Pomona, New York, from association with any broker or dealer. After one year, Kuznetz may apply to again become associated in a non-supervisory and non-proprietary capacity.

The sanction imposed was based upon findings that Kuznetz, while employed as a registered representative at the Nanuet, New York office of Thomson McKinnon Securities, Inc., violated the antifraud provisions of the securities laws in the sale of the common stock of Reserve Oil and Minerals Corporation.

INVESTMENT COMPANY ACT RELEASES

THE MITSUI BANK OF CANADA

An order has been issued exempting The Mitsui Bank of Canada from all provisions of the Investment Company Act so that it may offer U.S. dollar-denominated certificates of deposit and other debt securities in the United States. (Rel. IC-14359 - Feb. 7)
