CIVIL PROCEEDINGS

PROFESSIONAL ASSOCIATES AND ROBERT C. LABINE PERMANENTLY ENJOINED

The Chicago Regional Office announced that on March 21 the Commission obtained an order of permanent injunction against Professional Associates and Robert C. LaBine. The injunction was based on violations by the defendants of the registration, antifraud and securities broker registration provisions of the securities laws and the investment adviser registration and antifraud provisions of the Investment Advisers Act of 1940 related to the offer and sale of at least \$20 million of three different securities: interests in joint ventures leasing phonograph record masters; units in a Professional Associates Escrow Account; and Professional Associates Trust Accounts.
