ENFORCEMENT PROCEEDINGS

ORDER INSTITUTING PENNY STOCK BAR PROCEEDING AGAINST LEE GAHR

On December 7, the Commission instituted administrative proceedings against Lee E. Gahr (Gahr), a resident of Vancouver, British Columbia. The order seeks a penny stock bar against Gahr based on the entry of a default injunction by the U.S. District Court (SEC v. Lee E. Gahr and Chill Tech Industries, Inc., No. CV-S-00-1088-KJD-RJJ, D. Nev.). The injunction was based on the Commission's allegations that Gahr, the chief operating officer of Chill Tech Industries, Inc., made a variety of false and misleading statements about the company, including statements relating to its purported development of an environmentally-friendly, self-chilling beverage can.
