## COMMISSION ANNOUNCEMENTS

---

### TEMPORARY SUSPENSION OF OVER-THE-COUNTER TRADING IN THE SECURITIES OF SOLUCORP INDUSTRIES LTD.

The Commission announced the temporary suspension, pursuant to Section 12(k) of the Securities Exchange Act of 1934 (Exchange Act), of over-the-counter trading in the securities of Solucorp Industries Ltd. (Solucorp), at 9:30 a.m. on May 1, 1998, and terminating at 11:59 p.m. on May 14, 1998. Solucorp, a Canadian company with its headquarters located in Nyack, New York, is engaged in treating and disposing of contaminated soil and in the development, marketing and licensing of products for use in environmental cleanups.

The Commission temporarily suspended trading in the securities of Solucorp because of questions that have been raised about the accuracy and adequacy of publicly disseminated information concerning, among other things: (1) the negotiation, existence and terms of contracts entered into by Solucorp or its licensees during the period July 1, 1995 through the present; and (2) recently projected revenues. ## ENFORCEMENT PROCEEDINGS

---

### LESLIE DANISH, CPA, SANCTIONED PURSUANT TO RULE 102(e)

The Commission instituted public administrative proceedings pursuant to Rule 102(e) of the Commission's Rules of Practice against Leslie Danish, a CPA practicing in New York with the firm Richard A. Eisner, LLP. Simultaneously, the Commission accepted Danish's offer

of settlement; without admitting or denying the Commission's findings, he consented to the issuance of the Commission's Order, which denies him the privilege of appearing or practicing before the Commission as an accountant, provided, however, that he can apply for reinstatement after 18 months from the date of the order.

The Commission found that Danish engaged in improper professional conduct in connection with his audits of the financial statements for five subsidiaries of Towers Financial Corporation, Towers Healthcare Receivables Funding Corporations I through V, for their fiscal years ended June 30, 1992. The five Towers subsidiaries filed for protection under Chapter 11 of the Bankruptcy Code in March 1993, along with their parent. As explained in the Order, the Towers Chapter 11 Trustee determined that the financial statements for the Towers subsidiaries materially misrepresented the value of their assets, which were purportedly receivables purchased from healthcare providers with a value of \$155 million. The Chapter 11 Trustee concluded the net realizable value of these assets was only \$28.5 million. The Commission also found that the Towers subsidiaries had made under-collateralized loans to two of the most significant healthcare providers, instead of purchasing receivables from them, and that the Towers subsidiaries had not reported these loans at their net realizable value, with an appropriate allowance for doubtful accounts.

The Commission found that Danish departed from professional auditing standards by failing to exercise due care and to maintain an attitude of professional skepticism in the performance of the audits. With respect to the under-collateralized loans, the Commission found that Danish relied excessively on management representations, and concluded that there was no need for an allowance for doubtful accounts without seeking and obtaining sufficient competent evidential matter. #### **ADMINISTRATIVE AND CEASE AND DESIST PROCEEDINGS ORDERED AGAINST ROBERT BUCHHEIT, SR.**

The Commission announced the issuance of an Order Instituting Public Administrative and Cease and Desist Proceedings, Making Findings and Imposing Remedial Sanctions and a Cease and Desist Order pursuant to the Securities Act of 1933 (Securities Act) and the Securities Exchange Act of 1934 (Exchange Act) against Robert Francis Buchheit, Sr. (Buchheit). The Commission simultaneously accepted Buchheit's Offer of Settlement wherein he consents to the issuance of the Order without admitting or denying the Commission's findings therein. The Order provides that Buchheit be suspended from association with any broker or dealer for a period of six months and that Buchheit cease and desist from committing or causing any violations or any future violations of Sections 5(a) and 5(c) of the Securities Act and Section 15(a) of the Exchange Act.

The Order finds that Buchheit violated the securities and broker-dealer registration provisions of the federal securities laws

through his participation in a fraudulent scheme conducted by BeneFund, Inc. (BeneFund) and its president, Vernon R. Twyman, Jr. The Order also finds that Buchheit offered, sold, and caused a public distribution of BeneFund stock registered pursuant to Form S-8, and supervised a group a salesman who did the same. Finally, the Order finds that Buchheit acted as an unregistered broker-dealer in connection with the sales of BeneFund securities. (Rel. 33-7531; 34-39932; File No. 3-9595)
