INVESTMENT COMPANY ACT RELEASES

THE MUNDER FUNDS, INC., ET AL.

A notice has been issued giving interested persons until June 29 to request a hearing on an application filed by The Munder Funds, Inc., et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act. The order would permit the implementation, without prior shareholder approval, of new investment advisory and sub-advisory agreements (New Management Agreements) for a period of up to 150 days following the date on which a transfer of a controlling interest in Munder Capital Management occurs (but in no event later than November 30, 1998) (Interim Period). The order also would permit, following shareholder approval, the payment of all fees earned under the New Management Agreements during the Interim Period. (Rel. IC-23240 - June 3)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The Pacific Exchange filed a proposed rule change (SR-PCX-98-21) to increase its recommended fines under the Minor Rule Plan for disruptive action involving physical contact between members while on the options trading floor. Publication of the notice in the Federal Register is expected during the week of June 8. (Rel. 34-40063)

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-98-33) relating to exemptions from fidelity bonding requirements. Publication of the notice in the Federal Register is expected during the week of June 8. (Rel. 34-40065)

ACCELERATED TEMPORARY APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated temporary approval of a proposed rule change (SR-DTC-98-11) filed by The Depository Trust Company. The order will extend through May 31, 1999, the Commission's

temporary approval of DTC's standards for the admission of entities that are organized in a country other than the United States to become direct DTC participants. Publication of the proposal is expected in the Federal Register during the week of June 8. (Rel. 34-40064)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Chicago Stock Exchange (SR-CHX-97-25) amending the Minor Rule Plan to include violations of the Exchange's limit order display rule. Publication of the proposal is expected in the Federal Register during the week of June 8. (Rel. 34-40066)

IMMEDIATE EFFECTIVENESS OF PORTIONS OF PROPOSED RULE CHANGE

Portions of a proposed rule change filed by the National Association of Securities Dealers relating to NASD's Order Audit Trail System and record-keeping rules (SR-NASD-98-38) have become effective pursuant to Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of June 8. (Rel. 34-40069)
