INVESTMENT COMPANY ACT RELEASES

ARK FUNDS, ET AL.

An order has been issued on an application filed by ARK Funds, et al exempting applicants from Section 17(a) of the Act. The order permits a pension plan to transfer its assets to certain registered open-end management investment companies in exchange for shares of the companies. (Rel IC-24316 – February 25)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The Depository Trust Company filed a proposed rule change (SR-DTC-00-03) to allow DTC to establish a one-way depository link with SIS SegInterSettle AG (SIS), a Swiss depository. The link would establish a free-of-payment account at SIS for DTC. Publication of the proposal is expected in the Federal Register during the week of March 6 (Rel 34-42482).

The New York Stock Exchange filed a proposed change (SR-NYSE-99-34) that would amend its Allocation Policy and Procedures. Publication of the proposal is expected in the Federal Register during the week of March 6 (Rel 34-42487).
