ENFORCEMENT PROCEEDINGS

NYSE DISCIPLINARY ACTION AGAINST JEFFREY AINLEY HAYDEN SET ASIDE

The Commission has set aside the action of the New York Stock Exchange Inc. against Jeffrey Ainley Hayden. Hayden was charged with making unsuitable recommendations and misstatements about customers' financial status in customer account forms. The Exchange concluded these actions were inconsistent with just and equitable principles of trade. Although Hayden did not dispute the findings of violations or the appropriateness of the sanctions imposed, he did make procedural challenges based on the fact that over six years passed between the end of the actionable conduct and the institution of the Exchange's disciplinary action.

The Commission concluded that the delay in the underlying proceedings was inherently unfair and that fundamental fairness principles of the Exchange Act of 1934 require dismissal of this case. (Rel. 34-42772; File No. 3-9649)
