### THE SOUTHERN COMPANY, ET AL.

A notice has been issued giving interested persons until June 13, 2000, to request a hearing on a proposal by Southern Company, a registered public utility holding company, Southern Energy, Inc., a nonutility subsidiary company, Southern Energy Resources, Inc., a nonutility subsidiary of SEI, and SEI's nonutility subsidiaries, to extend the time in which SEI and its nonutility subsidiary companies may declare and pay dividends to their parent companies with respect to the securities of such companies, from time to time through October 15, 2002, out of capital or unearned surplus.
