INVESTMENT COMPANY ACT RELEASES

FIRST INVESTORS CORPORATION, ET AL.

An order has been issued on an application filed by First Investors Corporation, et al. permanently exempting them from Section 9(a) of the Investment Company Act, operative solely as the result of four injunctions entered by courts in the States of Maine and New York and the Commonwealths of Massachusetts and Virginia on December 20, 1993. (Rel. IC-20337 - June 7)

FIRST INVESTORS CORPORATION, ET AL.

An order has been issued on an application filed by First Investors Corporation, et al. permanently exempting them from Section 9(a) of the Investment Company Act, operative solely as the result of an injunction described in the application, entered by the United States District Court for the Southern District of New York on June 12, 1992. HOLDING COMPANY ACT RELEASES

THE COLUMBIA GAS SYSTEM, INC., ET AL.

A supplemental order has been issued authorizing a proposal by The Columbia Gas System, Inc., a registered holding company; Columbia's public utility subsidiary companies, Columbia Gas of Pennsylvania, Inc., Columbia Gas of Ohio, Inc., Columbia Gas of Maryland, Inc., Columbia Gas of Kentucky, Inc., and Commonwealth Gas Services, Inc. (Commonwealth Services); and Columbia's nonutility subsidiary companies, Columbia Gas System Service Corporation, Columbia LNG Corporation, Columbia Atlantic

Trading Corporation, TriStar Ventures Corporation, TriStar Capital Corporation, Columbia Natural Resources, Inc., Columbia Coal Gasification Corporation, Columbia Energy Services Corporation, Columbia Gulf Transmission Company, Columbia Gas Development Corporation, Commonwealth Propane, Inc., and Columbia Propane Corporation (collectively, Applicants). Commonwealth Services is authorized to engage in long-term debt financing of \$16 million and short-term debt financing of \$30 million through December 31, 1994. The Commission continues to reserve jurisdiction over \$38 million of Applicants' remaining financing request. (Rel. 35-26062)

SELF-REGULATORY ORGANIZATIONS

UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of three exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. The exchanges and number of issues are: Boston Stock Exchange - 4 issues (Rel. 34-34168); Chicago Stock Exchange - 11 issues (Rel. 34-34169); and Philadelphia Stock Exchange - 17 issues (Rel. 34-34170).

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-NYSE-94-08) filed by the New York Stock Exchange to provide for the full implementation by June 30, 1995 of NYSE's On-Line Comparison System, which will require comparison or close out of most transactions in listed stocks, rights and warrants on trade date. (Rel. 34-34153)

The Commission approved a proposed rule change (SR-PTC-94-01) filed by the Participants Trust Company relating to the designation by PTC of certain securities guaranteed by the Government National Mortgage Association as eligible securities. Publication of the order is expected in the Federal Register during the week of June 6. (Rel. 34-34154)

The Commission approved a proposed rule change (SR-DTC-94-01) filed by The Depository Trust Company to implement the standing instruction database feature of the enhanced institutional delivery system. (Rel. 34-34166)

PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-94-14) to amend Sections 1(b) and 1(c) to Article III of the NASD By-Laws and Schedule C to the By-Laws to modify the process by which an applicant applies for membership in Association. Publication of the proposal is expected in the Federal Register during the week of June 6. (Rel. 34-34156)

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-94-30) to adopt a "trade or fade" provision for the handling of orders other than public customer orders. Specifically, the trading crowd would be required to either satisfy the order at the disseminated price or update the existing market in the subject series. Publication of the proposal is expected in the Federal Register during the week of June 6. (Rel. 34-34158)

The Municipal Securities Rulemaking Board filed a proposed rule change (SR-MSRB-94-7) to require municipal securities dealers to keep records of gifts and gratuities given to others, including issuer officials and employees, in relation to municipal securities activities. The Commission is publishing this notice to solicit comments on the proposed rule change from interested persons. Publication of the notice is expected in the Federal Register during the week of June 6. (Rel. 34-34162)

The International Securities Clearing Corporation filed a proposed rule change (SR-ISCC-94-2) that provides access to the Japan Securities Clearing Corporation to the National Securities Clearing Corporation's New York Window services. Publication of the proposal is expected in the Federal Register during the week of June 13. (Rel. 34-34163; International Series Rel. 670)

APPROVAL OF PROPOSED RULE CHANGES AND ACCELERATED APPROVAL OF PROPOSED RULE CHANGES AND AMENDMENTS THERETO

The Commission approved proposed rule changes and granted accelerated approval of proposed rule changes and amendments thereto (SR-Amex-92-35, SR-CBOE-93-59, SR-NYSE-94-17, SR-PSE-94-07 and SR-Phlx-94-10) filed by the American Stock Exchange, Chicago Board Options Exchange, New York Stock Exchange, Pacific Stock Exchange, and Philadelphia Stock Exchange relating to narrow-based index options listing standards. Publication of the order is expected in the Federal Register during the week of June 6. (Rel. 34-34157)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-94-33) to accelerate to June 30, 1994 the termination date of the experimental quotation linkage between the London Stock Exchange and The Nasdaq Stock Market; the linkage had been scheduled to

terminate on October 31, 1994. Publication of the proposal is expected in the Federal Register during the week of June 6. (Rel. 34-34159; International Series Rel. 669)

The Municipal Securities Rulemaking Board filed a proposed rule change (SR-MSRB-94-6) to provide interpretative guidance concerning Rule G-37 on political contributions and prohibitions on municipal securities business. The Board, pursuant to Section 19(b)(3)(A) of the Act, filed the proposal as constituting a stated policy, practice, or interpretation with respect to the meaning, administration, or enforcement of an existing rule of the Board. This renders the proposal effective upon filing with the Commission. The Commission is publishing this notice to solicit comments on the proposed rule change from interested persons. Publication of the notice is expected in the Federal Register during the week of June 6. (Rel. 34-34161)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-MSRB-94-5) filed by the Municipal Securities Rulemaking Board pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934. The purpose of the proposed rule change is to provide procedures for dealers to seek relief from Rule G-37, in limited circumstances, and to clarify certain definitions in Rule G-37. The Commission granted accelerated approval of the proposed rule change to facilitate compliance with Rule G-37. The Commission also published notice to solicit comments on the proposed rule change from interested persons. Publication of order is expected in the Federal Register during the week of June 6. (Rel. 34-34160)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
