ENFORCEMENT PROCEEDINGS

COMMISSION SUSTAINS NASD DISCIPLINARY ACTION AGAINST DARRELL DALTON

The Commission has sustained NASD disciplinary action against Darrell Steven Dalton of Las Vegas, Nevada, formerly a sales manager of Pruco Securities Corp. The NASD had found that Dalton submitted to Pruco and filed with the NASD a Uniform Registration Form U-4 for another individual falsely representing that that individual had not been convicted of any felony. The NASD had censured Dalton, fined him \$1,000, and suspended him for 90 days.

The Commission found that Dalton recruited a registered representative to work at Pruco, and stated on the Form U-4 that that person had not been convicted of a felony, when in fact he did have a felony conviction. Dalton claimed that he thought that the conviction had been "dismissed," but recklessly did not investigate the matter further, despite obvious signs indicating that further investigation was warranted. The Commission noted also that the record suggested that Dalton may have actually known of the conviction at the time of filing the Form U-4. The Commission held that this conduct constitutes a violation of Article III, Section 1 of the NASD's Rules of Fair Practice, as inconsistent with just and equitable principles of trade. INVESTMENT COMPANY ACT RELEASES

AFD EXCHANGE RESERVES, ET AL.

A notice has been issued giving interested persons until December 9 to request a hearing on an application filed by AFD Exchange Reserves, et al. for a conditional order under Section 6(c) of the Investment Company

Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. Applicants seek to amend existing orders that permitted applicants to offer up to three classes of shares and to impose a contingent deferred sales charge (CDSC) on certain redemptions of two classes of shares and to waive the CDSC in certain circumstances. The order would permit applicants to issue and sell up to four classes of shares and to impose a CDSC on certain redemptions of shares, and to waive the CDSC under certain circumstances. (Rel. THE CHASE MANHATTAN BANK, N.A.

An order has been issued on an application by The Chase Manhattan Bank, N.A. (Chase) granting a conditional exemption from Section 17(f) of the Act to let Chase maintain securities of United States registered investment companies for which it serves as custodian or subcustodian in Malaysia with The Chase Manhattan Bank (M) Berhad. CASH ASSETS TRUST, ET AL.

A notice has been issued giving interested persons until December 12 to request a hearing on an application filed by Cash Assets Trust, et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Sections 18(f), 18(g) and 18(i) of the Act. The order would permit the Trust to offer two classes of shares representing interests in the same investment portfolio. (Rel. IC-20707 - November 16)
