### AMENDMENTS REGARDING DEREGISTRATION OF REGISTERED INVESTMENT COMPANIES

The Commission has issued a release adopting amendments to Form N-8F and Rule 8f-1 under the Investment Company Act, the form and rule that govern the deregistration of certain investment companies. The amendments simplify and reorganize Form N-8F and expand the circumstances in which investment companies may use the form. The Commission also has amended Regulation S-T to require that investment companies file Form N-8F on EDGAR. The amendments will become effective on June 1, 1999. ## ENFORCEMENT PROCEEDINGS

---

### ADMINISTRATIVE PROCEEDINGS AGAINST DANNY COOMER

The Commission, by consent, entered an Order Instituting Public Proceedings, Making Findings and Imposing Remedial Sanctions (Order) against Danny Lee Coomer (Coomer), formerly a registered representative at various broker-dealers, based on his criminal convictions. On September 1, 1998, Coomer was convicted by the state of Ohio for stealing money from clients and violating the Ohio Securities Act and was sentenced to ten years in prison. On August 31, 1998, Coomer was convicted by the United States Attorney for the Southern District of Ohio where he plead guilty to money laundering and stipulated that he committed the offenses of mail fraud and wire fraud. On January 4, 1999, he was sentenced to ten years in confinement, more than two million dollars in restitution, three years of supervised release and a special assessment of one hundred dollars for his federal crimes. The plea agreement with the United States Attorney was based on, among other things: 1) from 1990 through at least March 1998, Coomer convinced approximately one hundred individuals to invest more than two million dollars in securities; 2) Coomer told the investors that he would invest their money in Canadian Bonds and certain small business 3) instead of investing those funds, he used the money to pay his personal and

business expenses. Coomer, without admitting or denying the findings in the Commission's Order, other than jurisdiction and the convictions in both the state and federal court, consents to the Order barring him from the securities industry. The Commission thanks the Montgomery County Prosecutor's Office and the Office of the United States Attorney for the Southern District of Ohio for their assistance in this matter. On January 1, 1996, AEPSC and AEP's eight subsidiary electric utility companies began to realign their organizations to create four functional business units: (1) Power Generation; (2) Energy Transmission and Distribution; (3) Nuclear Generation; and (4) Corporate Development. To reflect changes in the services provided by AEPSC and the related cost allocations due to the reorganization, AEPSC proposes to amend its service agreements with AEP and the direct and indirect subsidiaries of AEP.
