INVESTMENT COMPANY ACT RELEASES

EMERGING MARKETS GROWTH FUND, INC., ET AL.

A notice has been issued giving interested persons until June 29 to request a hearing on an application filed by Emerging Markets Growth Fund, Inc. (Fund), et al. for an exemption from Sections 2(a)(3)(A) and (D) and 17(a) of the Investment Company Act, and under Section 17(d) and Rule 17d-1 to permit certain joint transactions. The order would permit the Fund to invest in an affiliated investment vehicle. (Rel. IC-23861 - June 7)

MORGAN STANLEY DEAN WITTER INSTITUTIONAL FUND, INC., ET AL.

An order has been issued on an application filed by Morgan Stanley Dean Witter Institutional Fund, Inc., et al. for an order under Section 17(d) of the Investment Company Act and Rule 17d-1 under the Act. The order permits certain registered management investment companies to deposit their uninvested cash balances into one or more joint accounts for the purpose of entering into short-term repurchase agreements. ALLEGIANCE TELECOM, INC.

An order has been issued on an application filed by Allegiance Telecom, Inc. under Section 6(c) of the Investment Company Act exempting applicant from all provisions of the Act until the earlier of one year from June 8, 1999, or the date applicant no longer may be deemed to be an investment company. (Rel. IC-23863 - June 8)

BERTHEL GROWTH & INCOME TRUST I, ET AL.

An order has been issued on an application filed by Berthel Growth & Income Trust I, et al. under Sections 6(c), 12(d)(1)(J), 57(c), and 57(i) of the Investment Company Act, and Rule 17d-1 under the Act, and under Section 12(h) of the Securities Exchange Act of 1934. The order would permit: (i) a small business investment company (SBIC) to file certain consolidated reports with a business development company (BDC); (ii) modified consolidated asset coverage requirements for senior securities issued by a BDC and its SBIC subsidiary; and (iii) a BDC and a SBIC to invest in securities in which the other is or proposes to be an investor, and to co-invest

in portfolio companies with certain affiliates. (Rel. IC-23864 - June 8)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change (SR-CBOE-99-22) filed by the Chicago Board Options Exchange relating to the market-maker surcharge fee schedule has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of June 7. (Rel. 34-41475)

The Depository Trust Company filed a proposed rule change (SR-DTC-99-13), which became effective upon filing, enhancing DTC's Repo Tracking System. Publication of the proposal is expected in the Federal Register during the week of June 7. (Rel. 34-41476)

National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-99-04), which became effective upon filing, amending NSCC's Annuities Processing Service (APS) to change the name of the service to "Insurance Processing Service," and makes corresponding name and clarification changes to reflect the nature of NSCC's service. Publication of the proposal is expected in the Federal Register during the week of June 7. (Rel. 34-41477)

The Pacific Exchange filed a proposed rule change (SR-PCX-99-14), which became effective immediately, relating to Amendments to its Rule 6.28(b) increasing the maximum order size eligible for automatic execution on Auto-Ex to fifty contracts during high volume or high volatility emergency situations. Publication of the proposal is expected in the Federal Register during the week of June 7. (Rel. 34-41481)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change (SR-NSCC-99-06) filed by the National Securities Clearing Corporation under Section 19(b) of the Exchange Act. The proposed rule change extends the temporary approval of additional procedures which govern the placement of NSCC members on Class A surveillance and the clearing fund deposit and other collateral requirements for such members. Publication of the proposal is expected in the Federal Register during the week of June 7. (Rel. 34-41478)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved, on a pilot basis until September 30, 2000, a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-98-32) relating to shareholder approval of stock option plans.

PROPOSED RULE CHANGE

The Options Clearing Corporation filed a proposed rule change (SR-OCC-99-01) to modify OCC's rules with respect to letters of credit accepted for margin purposes. Publication of the proposal is expected in the Federal Register during the week of June 14. (Rel. 34-41486)
