ENFORCEMENT PROCEEDINGS

ORDER MAKING FINDINGS AND IMPOSING REMEDIAL SANCTIONS ENTERED AGAINST EUGENE LAFF AND LAWRENCE CAITO

The Commission settled administrative proceedings against Eugene K. Laff (Laff) and Lawrence Caito (Caito). Both respondents, without admitting or denying the Commission's findings, consented to an Order barring them from association with any broker or dealer.

The administrative proceedings which led to the sanctions against Laff and Caito arose from injunctions entered against them for violating the antifraud provisions of the federal securities laws in connection with their participation in a major manipulation of certain securities during 1986 and 1987. Laff was the chairman and CEO of Haas Securities, a now defunct broker-dealer. Caito was the president and sole shareholder of Capital Shares, Inc., also defunct.
