Dear Chairman Powell:

More than three years ago, Nextel Communications charted a course with the leaders of our nation's public safety organizations to bring an end to the problem of interference between the radio operations of wireless carriers and first responders in the 800 MHz frequency band. Today, Nextel stands shoulder to shoulder with public safety and the Federal Communications Commission (FCC) and accepts the responsibilities, obligations, license modifications, and conditions specified in the FCC's Report and Order in WT Docket 02-55, "*Improving Public Safety Communications in the 800 MHz Band*,"¹ as modified by the subsequent errata, public notice and orders that have been issued by the Commission.²

The FCC's decision to solve public safety radio interference in the 800 MHz spectrum band is the right thing to do for first responders and our nation's homeland security. Nextel has already begun moving forward in order to complete the reconfiguration process in accordance with FCC rules. We take the obligations and responsibilities that come along with this initiative seriously and will meet all expectations fully. Eliminating the dangerous problem of public safety interference is far too important to do anything less.
