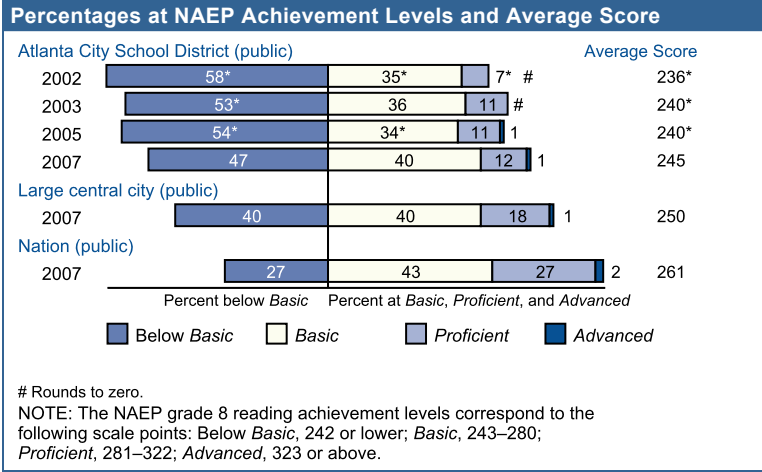


The National Assessment of Educational Progress (NAEP) assesses reading on a 0-500 point scale. In 2007, Atlanta City School District was one of eleven urban districts that voluntarily participated in the NAEP reading assessment on a trial basis.

Overall Reading Results for Atlanta

- In 2007, the average scale score for eighth-grade students in Atlanta was 245. This was higher than their average score in 2005 (240) and was higher than their average score in 2002 (236).¹
- Atlanta's average score (245) in 2007 was lower than that of public schools in large central cities² (250).
- The percentage of students in Atlanta who performed at or above the NAEP *Proficient* level was 13 percent in 2007. This percentage was not significantly different from that in 2005 (12 percent) and was greater than that in 2002 (8 percent).
- The percentage of students in Atlanta who performed at or above the NAEP *Basic* level was 53 percent in 2007. This percentage was greater than that in 2005 (46 percent) and was greater than that in 2002 (42 percent).

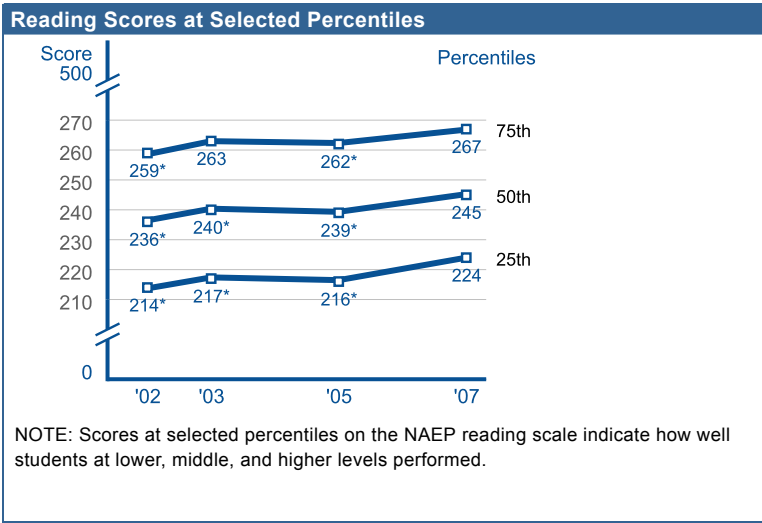

Average Score Gaps Between Selected Groups

- In 2007, male students in Atlanta had an average score that was lower than that of female students by 10 points. In 2002, the average score for male students was lower than that of female students by 9 points.
- Data are not reported for White students in 2007, because reporting standards were not met. Therefore, the performance gap results with Black students are not reported.
- Data are not reported for White and Hispanic students in 2007, because reporting standards were not met. Therefore, the performance gap results with Hispanic students are not reported.
- In 2007, students who were eligible for free/reduced-price school lunch, a proxy for poverty, had an average score that was lower than that of students who were not eligible for free/reduced-price school lunch by 23 points. This performance gap was wider than that of 2002 (11 points).
- In 2007, the score gap between students at the 75th percentile and students at the 25th percentile was 43 points. In 2002, the score gap between students at the 75th percentile and students at the 25th percentile was 45 points.

¹ Comparisons (higher/lower/narrower/wider/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages. Comparisons across jurisdictions and comparisons with the nation or within a jurisdiction across years may be affected by differences in exclusion rates for students with disabilities (SD) and English language learners (ELL). The exclusion rates for SD and ELL in Atlanta were 7 percent and 2 percent in 2007, respectively. ² "Large central city" includes public schools located in large central cities (population 250,000 or more) within metropolitan statistical areas as defined by the federal Office of Management and Budget. It is not synonymous with "inner city."
³ For comparison, non-White students comprised 77 percent of students in large central city public schools and 42 percent in public schools nationally at grade 8. Also, students eligible for free/reduced-price school lunch comprised 64 percent of students in large central city public schools and 40 percent in public schools nationally.
NOTE: Detail may not sum to totals because of rounding and because the "Information not available" category for the National School Lunch Program, which provides free and reduced-price lunches, and the "Unclassified" category for race/ethnicity are not displayed.
