

U. S. Environmental Protection Agency's FOIA Initial Requests and Administrative Appeals Backlog Reduction Goal For Fiscal Years 2008, 2009 and 2010

The Environmental Protection Agency (EPA) establishes the following goals as directed by the Department of Justice and E.O. 13,392 with respect to the number of FOIA requests and administrative appeals that are received and processed in the next three fiscal years (FY) as well as the goal as set out in EPA's Freedom of Information Act Improvement Plan for the number of requests it expects to be pending beyond the statutory time period at the end of each of the fiscal years for FY 2008, 2009 and 2010. EPA has also set out goals for the number of administrative appeals pending beyond the statutory deadlines for FY 2008, 2009 and 2010.
