Surface occupancy or use is subject to the following special operating constraints.

Unless otherwise authorized, surface occupancy will be prohibited within 100 feet of a perennial stream. This is to limit or mitigate impacts on flood plains, wetlands and riparian zones.

Surface occupancy or use is subject to the following special operating constraints.

Unless otherwise authorized, surface occupancy will be prohibited within 100 feet of a perennial stream. This is to limit or mitigate impacts on flood plains, wetlands and riparian zones.
