Transitioning to New Technologies

The workshop will address the operational approvals of key new technologies such as Performance Based Navigation (PBN) procedures as well as the implementation of GNSS (Global Navigation Satellite Systems) consistent with APEC 5th Transportation Ministerial Directives.

FAA officials, International Civil Aviation Organization (ICAO) representatives, APEC economies, and U.S. industry experts will discuss regulatory approaches and make technical presentations on such topics as:

- Area Navigation (RNAV) / Required Navigational Performance (RNP),
- Automatic Dependent Surveillance-Broadcast (ADS-B),
- Heads Up Displays (HUDs)
- Enhanced and Synthetic Vision Systems.
