<u>LOG EXPORT AND SUBSTITUTION RESTRICTIONS</u>: All timber offered for sale hereunder is restricted from export from the United States in the form of unprocessed timber and is prohibited from being used as a substitute for exported private timber.

<u>CRUISE INFORMATION</u>: With respect to merchantable trees of all species in all cruise strata: the average DBHOB is 12.1 inches: the average gross merchantable log contains 41 bd. ft.; the total gross volume is approximately 10158 m. bd. ft.; and 92% recovery is expected. The average DBHOB for Douglas-fir is 12.3 inches; and the average gross merchantable log contains 41 bd. ft. The following cruise methods were used for volume determination:

<u>VARIABLE PLOT</u>: Timber volumes were based on a variable plot cruise using the Behres volume equation or form class tables for estimating board foot volumes of trees in 16-foot logs. Five-hundred sixty nine (569) plots were measured using a 20 basal area factor (BAF). Three-thousand eighty six (3686) trees were randomly selected to be cruised.

<u>LOCAL VOLUME TABLE</u>: Timber volumes have been cruised using the local volume table system to select sample trees. The Douglas-fir sample trees were cruised using the Behres volume equation or form class tables for estimating board foot volumes of trees in 16-foot logs. Hemlock sample trees were cruised using form class tables for estimating board foot volumes of trees in 16-foot logs. The volumes are then expanded to a total sale volume.

<u>CUTTING AREA</u>: Twenty (20) units totaling approximately 620 acres must be partial cut.

<u>ACCESS</u>: Access to the sale area is provided via Oregon State highways, Coos County roads, Government controlled roads, and privately controlled roads.

<u>DIRECTIONS TO SALE AREA</u>: From Hwy 42, at Ten Mile, OR, turn north onto Reston Road to the Flournoy Valley (Coos Bay Wagon Road).
