ENVIRONMENTAL ASSESSMENTS or CATEGORICAL EXCLUSIONS were prepared for these sales, and a Finding of No Significant Impact has been documented. These documents are available for inspection as background for these sales at the Coos Bay District Office.

A WRITTEN BID on Form 5440-9 at not less than the appraised price on a unit basis per species and the required minimum bid deposit shall be required to participate in oral bidding for each tract.

PRE-AWARD QUALIFICATIONS. The high bidder may be required to furnish information to determine the ability to perform the obligations of the contract. If the high bidder is determined not qualified, responsible or refuses to respond within fifteen (15) days of a request for information pertaining to qualifications, the contract may be offered and awarded for the amount of the high bid to the highest of the bidders who is qualified, responsible, and willing to accept the contract.

LOG EXPORT AND SUBSTITUTION. All timber sales shall be subject to the restrictions relating to the export and substitution of unprocessed timber from the United States in accordance with P.L. 94-165 and 43 CFR 5400 and 5420, as amended.

ADDITIONAL INFORMATION concerning each timber sale tract described herein is available at the above District office. A copy of the timber sale contract is also available for inspection at the District office.

THE VOLUMES LISTED herein are estimates only, based on 16-foot taper breaks, which must be taken into consideration if comparisons are made with volume predictions based on other standards. The volumes based on 32-foot taper breaks are shown for comparison purposes. No sale shall be made for less than the advertised appraised price. The purchaser shall be liable for the total purchase price, without regard to the amount bid per unit, even though quantity of timber actually cut or removed or designated for taking is more or less than the estimated volume or quantity so listed.

<u>LOG EXPORT AND SUBSTITUTION RESTRICTIONS</u>: All timber offered for sale hereunder is restricted from export from the United States in the form of unprocessed timber and is prohibited from being used as a substitute for exported private timber.

<u>CRUISE INFORMATION</u>: With respect to merchantable trees of all species in all cruise strata: the average DBHOB is 11.3 inches: the average gross merchantable log contains 35 bd. ft.; the total gross volume is approximately 4559 m. bd. ft.; and 93% recovery is expected. The average DBHOB for Douglas-fir is 11.3 inches; and the average gross merchantable log contains 35 bd. ft. Approximately 0 trees which are considered to be nonmerchantable are designated for cutting. Approximately 0% of the total sale volume is salvage material. The following cruise methods were used for volume determination:

<u>VARIABLE PLOT</u>: Timber volumes were based on a variable plot cruise using the Flewelling volume equation or form class tables for estimating board foot volumes of trees in 16-foot logs. Two hundred eighty-six (286) plots were measured using a twenty (20) basal area factor (BAF). Two hundred fifty-five (255) trees were randomly selected to be cruised.

CUTTING AREA: Nine (9) units totaling approximately 257 acres must be partial cut.

<u>ACCESS</u>: Access to the sale area is provided via: Oregon State highways, Coos and Douglas County roads, Government controlled roads, and privately controlled roads.

<u>DIRECTIONS TO SALE AREA</u>: From Hwy 42, at Ten Mile, OR, turn north onto Reston Road to the Flournoy Valley (Coos Bay Wagon Road). Turn left (west) and proceed for approximately 4.1 miles to the Tioga Ridge Road (28-8-20.0) system (to Unit 4). Continue west along the Coos Bay Wagon Road for an additional 2.4 miles to the Knepper Creek Road (28-9-12.1) system (to Units 1-3).
