"CLEAN ENERGY COMMUNITIES" BACKGROUND


Designed as a partnership program between the Connecticut Clean Energy Fund and SmartPower, the Clean Energy Communities program provides qualified cities and towns free solar photovoltaic systems when they complete each of the following:

- 1.) Commit to the SmartPower "20% by 2010 Clean Energy Campaign";
- 2.) Sign-up local residents to the CTCleanEnergyOptionssm program through their local utility provider; and
- 3.) Devote the savings achieved by the free solar PV systems to support the town commitment to purchase clean energy.





CONNECTICUT CLEAN ENERGY COMMUNITIES



30 Towns in CT have passed resolutions committing to 20% clean energy by 2010

13 Towns have qualified as "Clean Energy Communities" receiving at least one 1kW solar energy system.





KEY DIFFERENCES BETWEEN STATES

Renewable Portfolio Standard

Connecticut: Electric providers must meet the standard with at least 7% Class I renewables and 3% Class I or II renewables by January 1, 2010,

Pennsylvania : The standard calls for utilities to generate 8% of their electricity by using "Tier I" energy sources and 10% using "Tier II" sources by May 31, 2021

• Municipal Incentive/Reward

Connecticut: For every 100 customers who sign up for clean energy the municipal government receives a 1kW solar energy systems – for towns located in load congested zones of SW Connecticut a 2kW system is awarded for every 200 signups

Pennsylvania: The municipal government receives a 1kW solar energy system when 7% of the community sign ups for clean energy OR customer demand is equal to 60,000kwh per month (approximately 200 new customers).





KEY DIFFERENCES BETWEEN STATES CONT...

• Clean Energy Suppliers

Connecticut: One standard state program with 2 clean energy providers offered

CTCleanEnergyOptions



Pennsylvania: No standard offer throughout the state. 3 separate providers with only one affiliated with the local utility:



• Municipal Government Structure

Connecticut: Customer address signifies the municipality that receives credit for clean energy signup.

Pennsylvania: Customer address does not signify the township, borough or city that should receive credit for clean energy sign up.





KEY SIMILARITIES BETWEEN STATES

• Partnered With a State Benefit Fund

Connecticut: The Connecticut Clean Energy Communities Program was developed in partnership with the Connecticut Clean Energy Fund (CCEF)






Pennsylvania : The Pennsylvania Clean Energy Communities Campaign was developed in partnership with the Sustainable Development Fund (SDF)

KEY SIMILARITIES BETWEEN STATES CONT....

Community Incentive

Connecticut: 1kW solar energy system for every 100 customers who sign up for clean energy. A \$10,000 value

Pennsylvania: 1kW solar energy system when 7% of the community signs up for clean energy or new customer demand is equal to 60,000 kilowatt hours per month. A \$10,000 value.

PENNSYLVANIA CLEAN ENERGY COMMUNITIES CAMPAIGN OVERVIEW

The campaign provides **10** qualified townships, borough and cities located in Bucks, Chester, Delaware, Montgomery and Philadelphia Counties with one **FREE** 1kW solar- photovoltaic systems when they meet 3 simple steps

How do you qualify as a Pennsylvania Clean Energy Community? Easy as 1-2-3!


For Pennsylvania communities to qualify for this campaign, they will need to meet the following requirements (in order) :

The community government must commit to purchase 20% of its electricity from clean energy by 2010.

Residents and business of the community must sign up to purchase clean energy in one of the two following amounts:

- 7% of the combined household and business population within the community must sign up for clean energy.
 OR –
- New household and business purchases of clean energy within the community must be equivalent to 60,000 kWhs per month.

Communities that have purchased clean energy and have qualified for the free 1kW solar energy system.







TAKE HOME TIPS FOR REPLICATING COMMUNITY PROGRAMS IN MULTIPLE STATES

- 1. Do your homework understand the dynamics of the community you are entering.
- 2. Collaborate with local NGO's, clean energy suppliers and utilities to develop and design a robust program.
- 3. Flexibility be willing to compromise on program logistics to fit the needs of local stakeholders.
- Develop strong relationships within the community i.e. attend local events, support your collaborator's initiatives, etc.
- 5. Recognize and celebrate each communities success!
