Gentlemen:

As you are probably aware, the public comment period on the *Site-Wide EIS for Continued Operation of LANL* (the SWEIS as we call it) recently closed and we are currently revising the SWEIS to produce a final document. Since both of you were extremely helpful for the draft, I thought I would direct my questions at both of you. To that end, I am in need of county water, natural gas, and electric power/peak load usage data for FY/CY 2005-2006 and any available data to date. This data will be compared to data compiled by LANL and presented in the final EIS.

Previously, you sent me a spreadsheet with DOE water sales for the period 2001-2005 (CY basis), so I am probably in need of the latest version.

You also sent me FY Consumption Report spreadsheets for numerous fiscal years through FY05 that included electric, gas, and water sales to county customers other than LANL. Could you provide the latest county (FY06) Consumption Report? The data you provided last time and time spent to respond to numerous questions was very much appreciated.

I have one question. In comparing the water data between the DOE water sales spreadsheet to the water sales information in the Consumption Reports, I would have expected the monthly totals in each spreadsheet equating to total county use/sales to be similar. However, I note that this is not the case. Is there some consideration I am missing in terms of sales to retail customers versus total county usage?

Again, I would greatly appreciate your help in collecting the above and would be happy to discuss with you if needed. Of course, please contact me with any immediate questions or if you need clarification. Thank you.

As you are probably aware, the public comment period on the *Site-Wide EIS for Continued Operation of LANL* (the SWEIS as we call it) recently closed and we are currently revising the SWEIS to produce a final document. Since both of you were extremely helpful for the draft, I thought I would direct my questions at both of you. To that end, I am in need of county water, natural gas, and electric power/peak load usage data for FY/CY 2005-2006 and any available data to date. This data will be compared to data compiled by LANL and presented in the final EIS.

Previously, you sent me a spreadsheet with DOE water sales for the period 2001-2005 (CY basis), so I am probably in need of the latest version.

You also sent me FY Consumption Report spreadsheets for numerous fiscal years through FY05 that included electric, gas, and water sales to county customers other than LANL. Could you provide the latest county (FY06) Consumption Report? The data you provided last time and time spent to respond to numerous questions was very much appreciated.

I have one question. In comparing the water data between the DOE water sales spreadsheet to the water sales information in the Consumption Reports, I would have expected the monthly totals in each spreadsheet equating to total county use/sales to be similar. However, I note that this is not the case. Is there some consideration I am missing in terms of sales to retail customers versus total county usage?

Again, I would greatly appreciate your help in collecting the above and would be happy to discuss with you if needed. Of course, please contact me with any immediate questions or if you need clarification. Thank you.
