- 1. This spreadsheet provides the Department of Veterans Affairs (VA) the DoD definition of combat operations for Title 10 Service members as designated by Combat Zone Tax Exclusion, Global War on Terrorism medals, lraq/Afghanistan campaign medals, and Hostile Fire / Imminent Danger Pay. Combat operations include those associated with the Persian Gulf, Bosnia, Kosovo, Operation Enduring Freedom, and Operation Iraqi Freedom. Updated by OUSD(P&R) 30 September 2008.
- DoD Country Codes are designated by Department of Defense Instruction 1336.5, Attachment 5 To Enclosure 4, dated May 2, 2001
- 3. DoD Limitation is based on Combat Zone Tax Exclusion (CZTE) provisions. If no CZTE provisions apply, then the DoD Limitation is based on provisions authorizing Global War on Terrorism (GWOT) and campaign medals. If no provisions for medals apply, the DoD Limitation is based on the provisions authorizing Hostile Fire / Imminent Danger Pay.
- 4. The Global War on Terrorism (GWOT) is defined by combat operations as part of: a) Operation Enduring Freedom (OEF), start date of October 7, 2001; and b) Operation Iraqi Freedom (OIF), start date of March 19, 2003. A "X" marking in this column associates the nation / body of water with award of a GWOT or campaign medal.
- 5. A Combat Zone Tax Exclusion (CZTE) area is designated in one of three ways: a) by the President via an Executive Order (EO); b) by the Congress via Public Law; or c) by SecDef via "in direct support" designation.
- 6. A Combat Zone (CZ) is an area that the President has designated by Executive Order (EO) as an area where US forces are engaged in combat; it remains in effect until terminated by EO. There are three operations designated CZs: EO 12744 (Arabian Peninsula, effective January 17, 1991), EO 13119 (Kosovo, effective March 24, 1999), and EO 13239 (Afghanistan, effective September 19, 2001).
- 7. A Qualified Hazardous Duty Area (QHDA) is an area that Congress has designated through legislation where the Armed Forces are entitled to the same benefits afforded service in a Combat Zone (CZ). There are two QHDAs: a) Public Law 104-117 (Bosnia-Herzegovina, effective November 12, 1995); and b) Public Law 106-21 (Kosovo, effective March 24, 1999).
- 8. The SecDef has the authority under Treasury Regulations to extend Combat Zone Tax Exclusion (CZTE) benefits to Service members performing military service outside of a Combat Zone (CZ) or Qualified Hazardous Duty Area (QHDA) when the SecDef determines: a) their service directly supports military operations in the CZ; b) their service qualifies them for Hostile Fire / Imminent Danger Pay (HF / IDP); and 3) the reason for paying HF / IDP is based on risks / dangers related to the CZ or QHDA. The SecDef has delegated this authority to USD(P&R).
- 9. Two medals apply to service in the Global War on Terrorism (GWOT): a) Global War on Terrorism Expeditionary Medal is authorized for members deployed abroad (foreign land, water and airspace outside the US and 200 nautical miles off the US) for service in GWOT operations on or after September 11, 2001 as designated by SecDef; and b) Global War on Terrorism Service Medal is authorized for members who participated in or served in support of GWOT operations on or after September 11, 2001 as designated by the SecDef. Service members serving in the qualifying area of eligibility for which the Iraq and Afghanistan Campaign medals were subsequently authorized are no longer authorized to receive the GWOT-EM after April 30, 2005 per PDUSD(P&R) memorandum dated April 6, 2005.
- 10. Campaign Medals fall under two categories: a) Afghanistan Campaign Medal (ACM) applies to service conducted on the land area of or airspace above Afghanistan; and b) Iraq Campaign Medal (ICM) applies to service conducted on the land area of and airspace above Iraq. These medals are not applicable for service or operations conducted in other countries.
- 11. Hostile Fire / Imminent Danger Pay (HF / IDP) recognizes Service members who are subject to hostile fire or explosion of hostile mines, and those on duty overseas who because of their role / visibility as a Service member, are subject to threat of physical harm or imminent danger due to civil insurrection, civil war, terrorism, or wartime conditions.
- 12. Members conducting boarding and searching vessel operations in the Mediterranean Sea qualify for the Global War on Terrorism Expeditionary Medal.
- 13. Global War on Terrorism (GWOT) operations conducted in Kosovo are approved for the Global War on Terrorism Expeditionary Medal, provided that the specified GWOT operation is not associated with operations qualifying for the Kosovo Campaign Medal.
