## 2008-09 Grand Cote Lottery Waterfowl Hunt Application Instructions

### How to apply:

- Complete the other side of this form and return the application to the Grand Cote NWR headquarters **by 4:00 pm on Friday, October 31, 2008.**
- Applications may be submitted by U.S. mail or hand delivered to 401 Island Road, Marksville, LA, 71351.
- Faxed applications **will not** be accepted.
- **Each application must include a \$5.00 application fee** in the form of a money order made payable to the U.S. Fish and Wildlife Service (no cash or personal checks accepted). Successful applicants will be notified by mail.

### Regulations:

- Selected hunters, 16 years old and older, must purchase a \$15.00 Central LA NWR Complex Special Recreational Activity Permit, available at the Refuge Headquarters or by ordering through the mail, prior to their hunt date. Hunters under 16 years of age must also possess a hunter's safety certificate.
- The Refuge reserves the right to cancel space-blind waterfowl hunts at any time due to lack of water availability, inclement weather, etc. No refunds will be provided in the event a hunt is canceled.
- All Federal, State and Refuge Regulations apply.
- Hunters must hunt their assigned blind location. A map of the blind locations will be posted in the parking lot across from the hunt area.
- Use of dogs is allowed. Dogs must be under hunter control at all times. **Do not** allow dogs to roam free when traveling to and from the blind area.
- Anything taken to blinds must be removed from the blind upon leaving, including spent shotgun shells, litter, decoys, etc. Sites will be monitored after hunts.
- All hunters must check in and check out at the Refuge Check Station on each hunt date and completely fill out a self-check in/out card.

### 2008-09 Grand Cote Lottery Waterfowl Hunt Permit

**You have been selected to participate in a lottery waterfowl space-blind hunt on Grand Cote National Wildlife Refuge in accordance with all applicable laws and regulations on the date & in the blind designated below.** Prior to hunting, you must also possess a Central LA NWR Complex Special Recreational Activity Permit available at the refuge office or via the mail (send your name, address, telephone number, and a \$15.00 money order made payable to the U.S. Fish and Wildlife Service to: Grand Cote NWR, 401 Island Road, Marksville, LA, 71351. **No credit cards or personal checks accepted.** Permits may also be purchased at Dupuy's Grocery, located 7 miles north of Marksville on Hwy 452. This permit is non-transferable and must be signed and carried on your person while on the refuge. This permit is subject to immediate cancellation for violation of refuge regulations.
